'THE PUNJAB LAND REVENUE (SPECIAL ASSESSMENTS) ACT, 1955.

(PUNJAB ACT No. 6 of 1956)

Be it enacted by the Legislature of the State of Punjab in the Seventh Year of the Republic of India as follows:—

1. (1) This Act may be called the Punjab Land Revenue (Special Short title, Assessments) Act. 1955. extent and

- (2) It extends to the whole of the State of ⁵[Haryana].
- (3) It shall come into force at once fin the principal territories and on the 15th May, 1958, in the transferred territories].

- 2. In this Act, unless there is something repugnant in the subject or context:—
 - (1) "Land" means land which for reasons specified in clause (f) of sub-section (1) of section 59 of the Land Revenue Act, 1887, as amended by Punjab Act, XIII of 1952, requires revision in the assessment of its land revenue.
 - (2) "Factory" means a factory as defined in section 2(m) of the Factory Act, 1948.
 - (3) Any expression used and not defined in this Act shall have the same meaning as is assigned to it in the Punjab Land Revenue Act, 1887.

Levy of Special assessment. 3. (1) With effect from the Kharif harvest, 1955 in the ¹[principal territories] and from the kharif harvest 1957 ²[transferred territories] and notwithstanding anything to the contrary contained in the Punjab Land Revenue Act (Act XVII of 1887), land under this Act shall be assessed to land revenue by Assistant Collector, First Grade, having jurisdiction, at the rates specified in the Schedule appended hereto:

Provided that the special assessment so levied shall not have the effect of adding to the value of any jagir or any assignment of and revenue.

- (2) Any person affected by an assessment made under subsection (1) may, within 30 days from the date of demand of the assessment, present a petition for reconsideration of the assessment so far as it affects him to the Assistant Collector who shall pass an order setting forth his reasons for granting or refusing it.
- (3) An appeal from an order of the Assistant Collector shall lie within thirty days to the Collector whose decision shall be final.

- 4. The assessment at the rates fixed in the Schedule shall remain Duration of in force till such time as special assessment is made by the Revenue special Officer in accordance with the provisions of the Punjab Land Revenue assessment. Act, 1887, and the Rules made thereunder.
- 5. Land revenue assessed under the Act shall be recoverable as Collections of land revenue under the Punjab Land Revenue Act, 1887.

²[Note— Where only one land revenue rate was fixed at settlement for Nehri land, that rate shall be taken as the rate of land revenue, while, in other cases including revenue-free lands, the highest Barani land revenue rate shall be taken as the land revenue rate for the purpose of special assessment under this Act.

³[Note II.— In relation to the ⁴[transferred territories] the land situated in the limits of District Boards, shall mean the lands situated out-side the limits of the municipalities and notified area committees.]

Validation.

⁵[Notwithstanding anything contained in the Punjab Land Revenue (Special Assessments) Act, 1955, or in any other law for the time being in force or in any judgment, decree or order of any court or other authority, where, at any time after the 15th day of May, 1958, and before the commencement of the Punjab Land Revenue (Special Assessment) Amendment and Validation Act, 1963, any special assessment has been made in respect of the land, situated outside the limits of municipalities and notified area committees in the ⁴[transferred territories], such special assessment shall be, and shall be deemed always to have been valid and shall not be questioned on the ground that such lands were not the lands situated in the limits of District Boards or that no District Boards were established in the said territories].
