ACT

to protect the publication of reports of proceedings of Haryana Legislative Assembly.

BE it enacted by the Legislature of the State of Haryana in the Twentyninth Year of the Republic of India as follows:-

- 1. This Act may be called the Haryana Legislative Assembly Shorttide. Proceedings (Protection of Publication) Act, 1978.
- 2. In this Act "newspaper" means any printed periodical work Definition. containing public news or comments on public news and includes a newsagency supplying material for publication in a newspaper.
- 3. (1) Save as otherwise provided in sub-section (2), no person shall Protection regardbe liable to any proceedings, civil or criminal, in any court in respect of the ing publication of publication in a newspaper of a substantially true report of any proceedings of Haryana Legislathe House of Haryana Legislative Assembly, unless the publication is proved proceedings. to have been made with malice.

- (2) Nothing in sub-section (1) shall be construed as protecting the publication of any matter, the publication of which is not for the public good.
- The Act shall also apply in relation to reports or matters broadcast. Act also to apply by means of wireless telegraphy or television as part of any programme or to Haryana Legislservice provided by any broadcasting station as it applies in relation to reports or matters published in a newspaper.
