THE ARUNACHAL PRADESH SALARY, ALLOWANCES AND PENSION OF MEMBERS OF THE LEGISLATIVE ASSEMBLY (AMENDMENT) ACT, 1987

(ACT NO. 6 OF 1987)

AN

to amend the Arunachal Pradesh Salary, Allowances and Pension of Members of the Legislative Assembly Act, 1983.

BE it enacted by the Legislative Assembly of Arunachal Pradesh in the Thirty-eighth Year of the Republic of India as follows:—

1. (1) This Act may be called the Arunachal Pradesh Salary, Allowances and Pension of Members of the Legislative Assembly (Amendment) Act, 1987.

Short title and commencement.

- (2) It shall come into force at once.
- 2. In section 2 of the Arunachal Pradesh Salary, Allowances and Pension of Members of the Legislative Assembly Act, 1983 (hereinafter referred to as the principal Act), in clauses (a) and (g) for the words "Union territory" the word "State" shall be substituted.

Amendment of section 2.

3. In section 3 of the principal Act, for the words "four hundred and fifty" the words "one thousand five hundred", for the words "two hundred" the words "five hundred" and for the word "forty" the words "seventy-five" shall be respectively substituted.

Amendment of section 3.

4. After section 4 of the principal Act, the following sections shall be inserted, namely:—

Insertion of sections 4A and 4B.

- "4A. With effect from the date of commencement of the Arunachal Pradesh Salary, Allowances and Pension of Members of the Legislative Assembly (Amendment) Act, 1987, a member shall be entitled to travelling allowance by air for the journeys performed by him for attending any business connected with his duties.
- 4B. The family members of a Member shall be allowed full reimbursement of the actual amount paid for journeys performed by them during the session of the Assembly from the usual place of residence to Itanagar and vice versa."

- 5. In section 5 of the principal Act, for the words. Amendment "Union territory" the word "State" shall be substituted. of section 5.
- 6. In section 6 of the principal Act, for the words Amendment "three days" the words "seven days" shall be substituted. of section 6.
- 7. In section 9 of the principal Act, for the words Amendment "Union territory" the word "State" shall be substituted, of section 9. and the "Explanation" shall be omitted.
- 8. After section 9 of the principal Act, the following Insertion of section shall be inserted, namely :--section 9A.
- "9A. Former Members may be allowed to medical treatment and attendance including all other benefits in connection therewith to the same extent as are provided to a sitting member of the Assembly."
- 9. In sub-section (1) of section 11 of the principal Amendment Act for the words "two hundred" the words "three of section 11. hundred" shall be substituted and in proviso thereof for the words "four hundred" the words "five hundred"
- 10. After section 11 of the principal Act, the following Insertion of sections shall be inserted, namely:—

 Insertion of section 11A

shall be substituted.

section 11A and IIB.

- "11A. With effect from the commencement of the Arunachal Pradesh Salary, Allowances and Pension of Members of the Legislative Assembly (Amendment) Act, 1987, a member shall be entitled to receive a Constituency Allowance at the rate of rupees one hundred fifty per mensem.
- IIB. Where electricity facilities are available at the place declared by a member to be his usual place of residence or at the place where he ordinarily transacted his business in connection with the Assembly, he shall be entitled to have connection of electricity at his residence :

Provided that the charge for such connection shall be borne by the Assembly Secretariat upto a limit of five thousand rupees and an appearance of the charge of five thousand rupees and an amount upto a limit of rupees two hundred per month towards consumption charges shall be reimbursed."

THE ARUNACHAL PRADESH SALARIES, ALLOWANCES AND PENSION OF MEMBERS OF THE LEGISLATIVE ASSEMBLY (AMENDMENT) ACT, 2000

(Act No. 4 of 2000)

AN ACT

further to amend the Arunachal Pradesh Salaries, Allowances and Pension of Members of the Legislative Assembly, 1983. (Act No. 8 of 1983).

BE it enacted by the Legislative Assembly of Arunachal Pradesh in the Fifty-first Year of the Republic of India as follows:-

 (1) This Act may be called the Arunachal Pradesh Salaries, Allowances and Pension of Members of the Legislative Assembly (Amendment) Act, 2000.

Short title and commencement

- (2) It shall come into force at once.
- 2. In the Arunachal Pradesh Salaries, Allowances and Pension of Members of the Legislative Assembly Act, 1983 (hereinafter referred to as the principal Act), for section 3, the following section shall be substituted, namely:—

Substitution of Section 3.

- "3. On and from the date the Arunachal Pradesh Salaries, Allowances and Pension of Members of the Legislative Assembly (Amendment) Act, 2000 comes into force, a Member shall be entitled to receive a salary at the rate of rupees six thousand and a conveyance allowance of rupees five hundred per mensem during the whole of his term of office and shall also be entitled to receive daily allowance at the rate applicable to Grade-1 (Group 'A') government employees for each day during any period of residence on duty".
- For section 11 of the principal Act, the following section shall be substituted, namely:—

Substitution of Section 11.

- "11 With effect from the commencement of this Act, there shall be paid a pension of rupees two thousand five hundred per mensem to every person who served for a period of four years, whether continuous or not —
- (i) as a member of the Assembly, or
- (ii) partly as a member of the Provisional Assembly and partly as a member of the Assembly:

Provided that where any person has served as aforesaid for a period exceeding five years, there shall be paid to him an additional pension of five hundred rupees per mensem, for every years in excess of five years".

Substitution of Section 11A.

- For section 11A of the principal Act, following section shall be substituted, namely:—
 - "11A. With effect from the commencement of this Act, a member shall be entitled to receive a constituency allowance at the rate of rupees two thousand per mensem".

THE ARUNACHAL PRADESH SALARIES, ALLOWANCES AND PENSION OF MEMBERS OF THE LEGISLATIVE ASSEMBLY (AMENDMENT) ACT, 2001

(ACT No. 7 of 2001)

AN

ACT

further to amend the Arunachal Pradesh Salaries, Allowances Pension of Members of the Legislative Assembly Act, 1983 (Act, No. 8 of 1982).

BE it enacted by the Legislative Assembly of Arunachal Pradesh in the Fifty-Second Year of the Republic of India as follows:-

- (1) This Act may be called the Arunachal Pradesh Salaries, Allowances and Pension of Members of the Legislative Assembly (Amendment) Act, 2001.
- Short title and commencement.
- (2) It shall come into force at once.
- (1) In the Arunachal Pradesh Salaries, Allowances and Pension of Members of the Legislative Assembly Act, 1983 (hereinafter referred to as the Principal Act), for section 3, the following section shall be substituted, namely:-
 - "3 On and from the date of Arunachal Pradesh Salaries, Allowances and Pension of Members of the Legislative Assembly (Amendment) Act 2001 comes into force, a Members shall entitled to receive a Salary at the rate of rupees Six thousand during the whole of his/her term of office and shall also be entitled to receive daily allowances at the rate applicable to Grade (Group 'A') government employee for each day during any period of residence on duty".
 - For section 10 of the Principal Act, following section shall be substituted, namely:-

"310 with effect from the commencement of this Act, a Member shall be entitled to receive rupees Twelve hundred per mensem being telephone charges" Substitution of Section 10.
