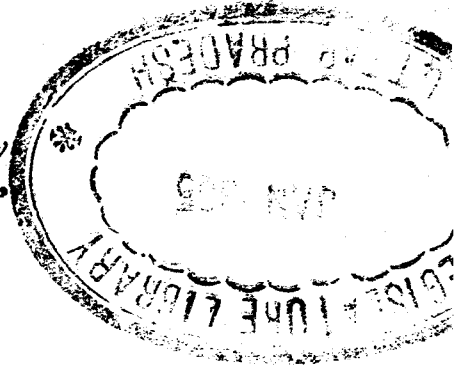

WHEREAS it is expedient to amend the U. P. Electricity (Temporary Powers of Control) Act, 1947, for certain purposes ;

U. P. Act VI of
1947.

IT IS HEREBY enacted in the Fourteenth Year of the Republic of India as follows :

1. (1) This Act may be called the Uttar Pradesh Electricity (Temporary Powers of Control) (Amendment) Act, 1963.

Short title and
extent.

(2) It extends to the whole of Uttar Pradesh.

2. In sub-section (4) of section 1 of the U. P. Electricity (Temporary Powers of Control) Act, 1947, for the figure "1963", the figure "1968" shall be substituted.

AN ACT

U. P. Act VI of 1947. to provide for the continuance, for a limited period, of the U. P. Electricity (Temporary Powers of Control) Act, 1947.

IT IS HEREBY enacted in the Twenty-first Year of Republic of India as follows :

Short title.

1. This Act may be called the Uttar Pradesh Electricity (Temporary Powers of Control) (Continuance) Act, 1970.

Amendment of section 1 of U. P. Act VI of 1947.

2. In sub-section (4) of section 1 of the U. P. Electricity (Temporary Powers of Control) Act, 1947, for the figures "1968", the figures "1973" shall be substituted.

Repeal of President's Act No. 26 of 1968.

3. The Uttar Pradesh Electricity (Temporary Powers of Control) (Continuance) Act, 1968, is hereby repealed.
