The following Act of the Andhra Pradesh Legislative Assembly received the assent of the Governor on the 11th May, 1990 and the said assent is hereby first published on the 14th May, 1990 in the Andhra Pradesh Gazette for general information:

ACT No. 9 OF 1990.

An Act further to amend the Telugu University Act, 1985.

Be it enacted by the Legislative Assembly of the State of Andhra Pradesh in the Forty-first Year of the Republic of India, as follows:—

- 1. (1) This Act may be called the Telugu University (Amendment) Act, 1990.
- (2) It shall be deemed to have come into force on short title the 5th February, 1990.

2. In the Telugu University Act, 1985, in section /, in sub-section (1), for the words "Chief Minister", the word "Governor" shall be substituted. Amendment of section 9,
