#### \*THE ORISSA SECONDARY EDUCATION (AMENDMENT) ACT, 1996

AN ACT FURTHER TO AMEND THE ORISSA SECONDARY EDUCATION ACT, 1952.

BE it enacted by the Legislature of the State of Orissa in the Forty-seventh Year of the Republic of India, as follows:—

Short title.

1. This Act may be called the Orissa Secondary Education (Amendment) Act, 1996.

Amendment of section 12.

- 2. In the Orissa Secondary Education Act, 1952 (hereinafter referred to as the Orissa Act principal Act),—
  10 of 1953.
  - (f) section 12 shall be renumbered as sub-section (1) thereof; and
  - (ii) after sub-section (1) so renumbered, the following sub-section shall be added, namely:—
    - "(2) The Board shall have such other funds as prescribed and maintain such accounts as the Board may determine.".

Amendment of section 21.

- 3. In the principal Act, in sub-section (2) of section 21, after clause (m), the Orissa Act following clause shall be inserted, namely:—

  10 of 1953.
- "(m-1) the constitution, maintenance and administration of the pension fund for the benefit of the employees and officers of the Board;"
