ACT NO. 23 OF 1990.

An Act further to amend the Andhra Pradesh Sugarcane (Regulation of supply and purchase) Act, 1961.

BE it enacted by the Legislative Assembly of the State of Andhra Pradesh in the forty-first year of the Republic of India as follows:-

1. This Act may be called the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Amendment Act, 1990. . Short Title.

2. In the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Act, 1961, in sub-section (1) of section 21, for the words "sixteen rupees", the words "thirty Amendment of Section 21, rupees" shall be substituted. Act, XLV of 1961.

An Act further to amend the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Act, 1961.

Be it enacted by the Legislative Assembly of the State of Andhra Pradesh in the Forty-sixth Year of the Republic of India, as tollows:—

- 1. (1) This Act may be called the Andhra Pradesh Sugarcane Short title (Regulation of Supply and Purchase) (Amendment) Act, 1995 and commencement.
- (2) It shall be deemed to have come into force with effect from the 6th January, 1995
- 2. In the Andhra Pradesh Sugarcane (Regulation of Supply Amendment and Purchase) Act, 1961, in sub-section (1) of section 21, for of Section 21 the words "thirty rupees", to the words one hundred rupees" 1961.
- 3. The Andhra Pradosh Sugarcane (Regulation of Supply Repeal of and Purchase) (Amendment) Ordinance, 1995 is hereby ordinance of 1995.

The following Act of the Andhra Pradesh Legislative Assembly received the assent of the Governor on the 20th April, 2000 and the said assent is hereby first published on the 22nd April, 2000 in the Andhra Pradesh Gazette for general information:-

ACT NO. 6 OF 2000

AN ACT FURTHER TO AMEND THE ANDHRA PRADESH SUGARCANE (REGULATION OF SUPPLY AND PURCHASE) ACT, 1961.

Be it enacted by the Legislative Assembly of the State of Andhra Pradesh in the Fifty-first Year of the Republic of India as follows:-

 - (2) It shall be deemed to have come into force on the 27th December, 1999.
 - Amendment 2. In the Andhra Pradesh Sugarcane of (Regulation of Supply and Purchase) Act, section 21. 1961, for clause (a) in sub-section A.P. Act XLV (3-D) of section 21, the following of 1961. clause shall be substituted, namely:-
 - "(a) sub-sections (4) and (5) shall apply from the date of purchase of sugarcane from the growers."
 - Reparl 3. The Andhra Pradesh Sugarcane of Ordinance (Regulation of Supply and Purchase) No. 7 of 1999.(Amendment) Ordinance, 1999 is hereby repealed.

STATEMENT OF OBJECTS AND REASONS

The Hon'ble Supreme Court in its Judgement dated 28-4-1999 in Civil Appeal No.903/84 filed by M/s.V.V.S. Sugars have observed that interest can be levied and charged on delayed payments of tax only if the statute is having substantive provision in this behalf. As there is no provision in the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Act, 1961, to levy interest on the delayed payment of tax, the Government bave decided to collect interest on delayed payment of purchase tax by way of suitably amending section 21 of the A.P. Sugarcane (Regulation of Supply and Purchase) Act, 1961 in tune with the judgement of the Supreme Court.

- 2. As the Legislative Assembly was not then in session and it has been decided to give affect to the above decision immediately, the Andhra Pradesh Sugarcane—(Regulation of Supply and Purchase) (Amendment) Ordinance, 1999 (Andhra Pradesh Ordinance No.7 of 1999) has been promulgated by the governor on the 24th December, 1999.
 - 3. This bill seeks to replace the said Ordinance.
