ACT NO. 23 OF 1990.

An Act further to amend the Andhra Pradesh Sugarcane (Regulation of supply and purchase) Act, 1961.

BE it enacted by the Legislative Assembly of the State of Andhra Pradesh in the forty-first year of the Republic of India as follows:-

Short Title.

1. This Act may be called the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Amendment Act, 1990.

Amendment of Section 21, Act, XLV of 1961.

2. In the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Act, 1961, in sub-section (1) of section 21, for the words "sixteen rupees", the words "thirty rupees" shall be substituted.

**THE ANDHRA PRADESH SUGARCANE
(REGULATION OF SUPPLY AND PURCHASE)
(AMENDMENT ACT), 1995.**

ACT No. 10 OF 1995*

[10th Feb, 1995]

An Act further to amend the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Act, 1961.

Be it enacted by the Legislative Assembly of the State of Andhra Pradesh in the Forty-sixth Year of the Republic of India, as follows :—

1. (1) This Act may be called the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) (Amendment) Act, 1995 Short title and commencement.

(2) It shall be deemed to have come into force with effect from the 6th January, 1995

2. In the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Act, 1961, in sub-section (1) of section 21, for the words "thirty rupees", to the words "one hundred rupees" shall be substituted. Amendment of Section 21 of Act XLV of 1961.

3. The Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) (Amendment) Ordinance, 1995 is hereby repealed. Repeal of Ordinance of 1995.

ACT NO. 6 OF 2000

**AN ACT FURTHER TO AMEND THE ANDHRA
PRADESH SUGARCANE (REGULATION OF
SUPPLY AND PURCHASE) ACT, 1961.**

Be it enacted by the Legislative Assembly of the State of Andhra Pradesh in the Fifty-first Year of the Republic of India as follows:-

Short title and commencement. 1. (1) This Act may be called the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) (Amendment) Act, 2000.

(2) It shall be deemed to have come into force on the 27th December, 1999.

Amendment of section 21. A.P. Act XLV of 1961. 2. In the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Act, 1961, for clause (a) in sub-section (3-D) of section 21, the following clause shall be substituted, namely:-

"(a) sub-sections (4) and (5) shall apply from the date of purchase of sugarcane from the growers."

Repeal of Ordinance No. 7 of 1999. 3. The Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) (Amendment) Ordinance, 1999 is hereby repealed.

STATEMENT OF OBJECTS AND REASONS

The Hon'ble Supreme Court in its Judgement dated 28-4-1999 in Civil Appeal No.903/84 filed by M/s.V.V.S. Sugars have observed that interest can be levied and charged on delayed payments of tax only if the statute is having substantive provision in this behalf. As there is no provision in the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) Act, 1961, to levy interest on the delayed payment of tax, the Government have decided to collect interest on delayed payment of purchase tax by way of suitably amending section 21 of the A.P. Sugarcane (Regulation of Supply and Purchase) Act, 1961 in tune with the judgement of the Supreme Court.

2. As the Legislative Assembly was not then in session and it has been decided to give affect to the above decision immediately, the Andhra Pradesh Sugarcane (Regulation of Supply and Purchase) (Amendment) Ordinance, 1999 (Andhra Pradesh Ordinance No.7 of 1999) has been promulgated by the governor on the 24th December, 1999.

3. This bill seeks to replace the said Ordinance.
