## ACT No. 27 OF 1991\*

[26th October, 1991]

AN ACT FURTHER TO AMEND THE ANDHRA PRADESH OPEN UNIVERSITY ACT, 1982.

BE it enacted by the Legislative Assembly of the State of Andhra Pradesh in the Forty-second Year of the Republic of India, as follows:-

1. This Act may be called the Andhra Short Pradesh Open University (AmendmentO Act, title 1991.

- Amendment of 2. In the Andhra Pradesh Open Univerthe long title sity Act, 1982 (hereinafter referred to as Act 11 of 1962 the principal Act) in the long, title, after the words "an Open University", the words "by the name Dr. B.R. Ambedkar Open University" shall be inserted.
- Amendment of 3. In section 1 of the principal Act, section 1. in sub-section (1), for the expression "the Andhra Pradesh Open University Act, 1982", the expression "Dr. B. R. Ambedkar' Open University Act, 1982" shall be substituted.
- Amendment of 4. In section 2 of the principal Section 2. Act, in clause (0), for the words "the Andhra Pradesh Open University", the words "Dr. B. R. Ambedkar Open University" shall be substituted.
- Amendment of 5. In Section 3 of the principal Act, section 3. in sub-section (1), for the words "the Anchre Pradesh Open University", the words "Dr. B. R. Ambedkar Open University" shall be substituted.
