Further to amend 'The Speaker and Deputy Speaker of the Legislative Assembly of the National Capital Territory of Delhi (Salaries & Allowances) Act, 1994'.

Be it enacted by the Legislative Assembly of the National Capital Territory of Delhi in the Forty Sixth Year of the Republic of India as follows:—

- 1. Short Title and Commencement.—(1) This Act may be called 'The Speaker and Deputy Speaker of the Legislative Assembly of the National Capital Territory of Delhi (Salaries & Allowances) (Amendment) Act, 1995'.
- (2) It shall come into force on such date as the Lt. Governor may, by notification in the official Gazette appoint.
- 2. Omission of Section 6.—In the Speaker and Deputy Speaker of the Legislative Assembly of the National Capital Territory of Delhi (Salaries & Allowances) Act, 1994 (Delhi Act of 1995), section 6 shall be omitted.

Further to amend The Ministers of the Government of the National, Capital Territory of Delhi (Salaries & Allowances) Act, 1994.

Be it enacted by the Legislative Assembly of the National Capital Territory of Delhi in the Forty Sixth Year of the Republic of India as follows:—

- 1. Short Title and Commencement.—(1) This Act may be called 'The Ministers of the Government of the National Capital Territory of Delhi (Salaries & Allowances) (Amendment) Act, 1995'.
- (2) It shall come into force on such date as the Lieutenant Governor may, by notification in the official Gazette, appoint.
- 2. Amendment of Section 3.—In 'The Ministers of the Government of the National Capital Territory of Delhi (Salaries & Allowances) Act, 1994 (Delhi Act 8 of 1995)' (hereianter referred to as "the principal Act"), in section 3, subsection (3) shall be omitted.
