Functions .--

(a) to enter and search and place;

- (b) to seize any drug, alongwith the contrainers, packages, or coverings in which the drug is found, in respect of which he suspects that any provision of this Order has been, is being or is about to be, contravened, and thereafter take all measures necessary for securing production of the drug, containers, packages or coverings, so seized, in a court of law and for their safe custody pending such p. oduction;
- (c) to seize any document, such as, cash memo books, books of account and records of purchase and sale of the drugs in respect of which he suspects that any provisions of this Order has been, is being, or is about to be contravened.

An Act to extend the Indian Easements Act, 1882, to the State of Punjab.

BE it enacted by the Legislature of the State of Punjab in the Twelfth Year of the Republic of India as follows:

1. Short title.—This Act may be called the Indian Easements (Punjab Extension) Act, 1961.

1. For statement of Objects and Reasons, see Punjab Gazette (Extra.) dated September 20, 1961. 2. Extension of the Indian Easements Act, 1882 to the State of Punjab.—The Indian Easements Act, 1882, is hereby extended to <sup>1</sup>[the territories specified in sub-section (1) of section 5 of the Punjab Reorganisation Act, 1966].

3. Repeal.—The Patiala Easements Act, 2002 B. K. (Pepsu Act No. XVI of 2002 BK) is hereby repealed :

Provided that anything done or any action taken under the Act hereby repealed shall be deemed to have been done or taken under the corresponding provisions of the Indian Easements Act, 1882.

No. Vidyut-Chh (5) 16/89.—In exercise of the powers conferred by section 51 of the Indian Electricity Act, 1910 (Act No. 9 of 1910) the Governor, Himachal Pradesh, is pleased to confer the powers of Telegraphs Act, 1885 (Act No. 13 of 1885) subject to the conditions/ restrictions imposed thereunder, with respect to placing of telegraph lines and posts for the purpose of the telegraph established or maintained by the Government, on the officers not below the rank of S.D.O.'s of the Punjab State Electricity Board, for laying of 220 KV Single Circuit Line from Bhakra Right Bank to Mahilpur in respect of area falling in Himachal Pradesh territory.
