- An Act to amend the Provincial Small Cause Courts Act, 1887 (Central Act 9 of 1887) in its application to the [State] of Himachal Pradesh.

BE it enacted by the Legislative Assembly of Himachal Pradesh in the Twentieth Year of the Republic of India as follows:

- 1. Short title and extent.—(1) This Act may be called the Provincial Small Cause Courts (Himachal Pradesh Amendment) Act, 1969.
 - (2) It shall extend to the whole of Himachal Pradesh.
- 2. Amendment of section 15 of Central Act 9 of 1887.—In section 15 of the Provincial Small Cause Courts Act, 1887 (Central Act No. 9 of 1887) in its application to the [State] of Himachal Pradesh:—
 - (1) In sub-section (2), for the words "five hundred", the words "two thousand" shall be substituted; and
 - (2) Sub-section (3) shall be omitted.
- 3. Repeal and savings.—The Provincial Small Cause Courts (Punjab Amendment) Act, 1966 (3 of 1966) as in force in the areas added to Himachal Pradesh under section 5 of the Punjab Re-organisation Act, 1966 (31 of 1966) is hereby repealed:

Provided that anything done or any action taken under the said Act shall be deemed to have been done or taken under this Act.
