## [THE 1(TAMIL NADU) DISTRICT LIMITS ACT, 1865.]

(Received the assent of the Governor on the 12th December 1864, and of the Governor-General on the 5th January 1865.)

An Act to provide for the alteration of the \*\* \* \* limits of Districts or Zilas in the 4[State of Tamil Nadu].

<sup>1</sup> Short title, "The Medras District Limits Act, 1865" wes given by the Repealing and Amending Act, 1901 (Central Act XI of 1901).

The whole of the Act, except so much as empowered the State Government to alter the limits of existing districts, was repealed by the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873).

This Act was extended to the Kanyakumari district and the Shencottab taluk of the Tirunelv. Ii district by section 3 of, and the First Schedule to, the Tamil Naou (Transferred Territory) Extension of Laws Act, 1960 (Tamil Nadu Act 23 of 1960), which came into force on the 1st April 1961, repealing the corresponding law in that territory.

<sup>4</sup> This expression was substituted for the expression "Madras Presidency" by the Tamil Nadu Adaptation of Laws Order, 1970, which was deemed to have come into force on the 14th January 1969.

5 The words "Provincial Government" were substituted for the words "Governor in Council" by the Adaptat on Order of 1937 and the word "State" was substituted for "Provincial" by the Adaptation Order of 1950.
