[THE '[TAMIL NADU] REPEALING AND AMENDING ACT, 1952.]

(Received the assent of the Governor on the 12th December 1952; first published in the Fort. St. George Gazette on the 17th December 1952.)

An Act to repeal certain enactments and to amend certain other enactments

WHEREAS it is expedient that the enactments specified in the First Schedule which are spent or have otherwise become unnecessary, or have ceased to be in force otherwise than by expressed specific repeal, should be expressly and specifically repealed;

AND WHEREAS it is also expedient that certain amendments should be made in the enactments specified in the second Schedule; It is hereby enacted as follows:—

- Short title 1. This Act may be called the [Tamil Nadu] Repealing and Amending Act, 1952.
- Repeal of 2. The enactments specified in the First Schedule certain enact- are hereby repealed to the extent mentioned in the fourth ments. column thereof.
- Amen at 3. (1) The enactments specified in the Second Schedule of certaindments are hereby amended to the extent and in the manner enactments. mentioned in the fourth column thereof.
 - (2) The amendment to the '[Tamil Nadu] Shops and Establishments Act, 1947 ('[Tamil Nadu] Act XXXVI of 1947), specified in the Second Schedule shall be deemed to have come into force on the 1st day of April 1951.
 - Savings. 4. The repeal by this Act of any enactment shall not affect any other enactment in which the repealed enactment has been applied, incorporated or referred to 1

and this Act shall not affect the validity, invalidity, effect or consequences of anything already done or suffered, or any right, title, obligation or liability already acquired, accrued or incurred, or any remedy or proceeding in respect thereof, or any release or discharge of or from any debt, penalty, obligation, liability, claim or demand, or any indemnity already granted, or the proof of any past act or thing;

nor shall this Act affect any principle or rule of law or established jurisdiction, form or course of pleading, practice or procedure, or existing usage, custom, privilege, restriction, exemption. office or appointment, notwithstanding that the same respectively may have been in any manner affirmed, recognized or derived by, in or from any enactment, hereby repealed;

nor shall the repeal by this Act of any enactment revive or restore any jurisdiction, office, custom, liability, right, title, privilege, restriction, exemption, usage, practice, procedure or other matter or thing not now existing or in force.
