An Act further to amend the Provincial Insolvency Act, 1920 in its application to the ³[State of Tamil Nadu]

WHEREAS it is expedient further to amend the Provincial Insolvency Act, 1920, (Central Act V of 1920), in its application to the ⁸[State of Tamil Nadu] for the purpose hereinafter appearing ; It is here by enacted as follows :----

Short title 1. This Act may be called the Provincial Insolvency (¹[Tamil Nadu] Amendment) Act, 1953.
