An Act to amend certain enactments consequent on the coming into force of the Indian Coinage ( 1 mendment) Act, 1955.

Whereas it is expedient to amend ceriain enactments consequent on the coming into force of the Indian Coinage (Amendment) Act, 1955 (Central Act 31 of 1955) ;

Be it enacted in the Eleventh Year of the Republic of India as follows :-

1. (1) This Act may be called the ${ }^{1}$ [Tamil Nadu] Coinage (Alteration of References) Act, 1960.
