# THE <sup>1</sup>[TAMIL NADU] GIFT GOODS (UNLAWFUL POSSESSION) ACT, 1961.

[Received the assent of the Governor on the 8th January 1962, first published in the Fort St. George Gazette on the 17th January 1962 (Pausa 27, 1883).]

### An Act to provide for the punishment of the offence of unlawful possession of gift goods supplied by certain relief organizations.

WHEREAS it is expedient to provide for the punishment of the offence of unlawful possession of gift goods supplied by certain relief organizations;

BE it enacted in the Twelf.h Year of the Republic of India as follows :---

1. (1) This Act may be called the <sup>1</sup>[Tamil Nadu] Gift Goods (Unlawful Possession) Act, 1961.

Short title, extent and commence ment.

(2) It extends to the whole of the <sup>3</sup>[State of Tamil Nadu].

(3) It shall come into force atonce.

## 2. In this Act, unless the context otherwise requires,—

<sup>1</sup>[(1) "gif: goods" means any of the following goods when supplied by way of gift, by any relief organization to any State Government or to the Central Government or to any other person on behalf of such Government, namely :---

(a) cornmeal;

(b) milk powder;

(c) vegetable oil (soya bean oil or sunflower seed oil);

(d) any other goods which the State Government may, by notification, from time to time, specify,]

(2) "relief organization" means any organization specified in the Schedule appended to this Act.

Unlawfu possession of gift goods. 3. If any person is found, or is proved to have been, in possession of any gift goods reasonably suspected of being stolen or unlawfully obtained, and cannot account satisfactorily how he came by the same, he shall be punished with imprisonment, for a term which may extend to two years, or with fine, or with both.

4. (1) Notwithstanding anything contained in the Code of Criminal Procedure, 1898 † (Central Act V of 1898) any offence under this Act shall be deemed to be a cognizable offence within the meaning of that Code.

#### Gift Goods (Unlawful Possession)

(2) No court below that of a \*Presidency Magistrate or of a \*Magistrate of the First Class shall try any offence under this Act.

5. The State Government may, by notification add Power to amend any organization to, or omit any organization from, the sche cute. Schedule; and on the publication of such notification, such organisation shall be deemed to be include in, or as the case may be, omited from, he Schedule.

6. (a) Every no ifica ion issued under this fic, shall Notifications to be placed before come into force on the cay on which i is published. I be placed before the Legislature.

(b) Every notification issued under this Act shall, as soon as possible, after it is issued, be placed on the table of both Houses of the Legislature and if before the expiry of the session in which it is so placed, or the next session, both Houses agree in making any modification in any such notification or both. Houses agree that the notification should not be issued, the notification shall thereafter have effect only in such modified form or be of no effect, as the case may be, so however, that any such modification or annulment shall be without prejudice to the validity of anything previously cone under that notification.

\*According to clauses (a) and (c) of sub-section (3) of section 3 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), any reference to a Magistrate of the first class shall be construed as a reference to a Judicial Magistrate of the first class and any reference to a Presidency Magistrate shall be construed as a reference to a Metropolitan Magistrate with effect on and from the 1st April 1974.
