THE TRAVANCORL GOCHIN LIME-SHELLS (CONTROL) REPEAL ACT, 1964.

[Received the assent of the Governor on the 9th Ivovember 1964, first published in the Fort St. George Gazette on the 18th November 1964 (Kartika 27, 1886).]

An Act to repeal the Travancore-Cochin Lime-shells (Control) Act, 1956, in its application to the Kanya-kumari district and the Shencottah taluk of the Tjrunelveli district.

Be it enacted by the Legislature of the ³[State of Tamil Nadu] in the Fifteenth Year of the Republic of India as follows:—

- 1. This Act may be called the Travancore-Cochin Short title. Lime-shells (Control) Repeal Act, 1964.
- 2. The Travancore-Cochin Lime-shells (Control) Act, Repeal of Presid1956 (President's Act XI of 1956), in its application to the ent's Act XI of
 Kanyakumari district and the Shencottah taluk of the
 1956.
 Tirunelyeli district, is hereby repealed to the extent to
 which that Act relates to matters with respect to which
 the State Legislature has power to make laws for the State.
