**HE '[TAMIL NADU] CULTIVATING TENANTS PROTECTION (CONTINUANCE) ACT, 1965.** 

**Received** the assent of the President on the 9th April 1965, first published in the Fort St. George Gazette on the 21st April 1965 (Vaisaka 1, 1887).]

In Act to provide for the continuance of the <sup>1</sup>[Tam'l Nadu] Cultivating Tenants Protection Act, 1955.

This Act may be called the <sup>1</sup>[Tamil Nadu] Cultiva- Short title ing Tenants Protection (Continuance) Act, 1965.

2. The <sup>2</sup>[Tamil Nadu] Cultivating Tenants Protection 4[Tamil Nadu Act, 1955 (<sup>4</sup>[Tamil Nadu] Act XXV of 1955) (hereinafter Act] XXV of referred to as the principal Act) shall, as amended by 1965 to be a permanent his Act, become a permanent Act.

3-5. [The amendments made by these sections have already been incorporated in the principal Act, amely, the Tamil Nadu Cultivating Tenants Protection Act, 1955 (Tamil Nadu Act XXV of 1955).]
