TAMIL NADU ACT NO. 43 OF 1979.*

THE PRESIDENCY SMALL CAUSE COURTS, CODE OF CIVIL PROCEDURE AND TAMIL NADU COURT-FEES AND SUITS VALUATION (AMEND-MENT) ACT, 1979.

Received the assent of the President on the 11th July 1979, first published in the Tamil Nadu Government Gazette Extraordinary on the 18th July 1979 (Adi 2, Chitharthi (2010-Tiruvalluvar Andu)).]

An Act further to amend the Presidency Small Cause Courts Act, 1882, the Code of Civil Procedure, 1908 and the Tamil Nadu Court-fees and Suits Valuation Act, 1955.

BE it enacted by the Legislature of the State of Tamil Nadu in the Thirtieth Year of the Republic of India as follows :---

1. (1) This Act may be called the Presidency Small short title. Cause Courts, Code of Civil Procedure and Tamil Nadu extent and Court-fees and Suits Valuation (Amendment) Act, 1979. commencement.

(2) It extends to the whole of the State of Tamil Nadu.

(3) It shall come into force on such date as the State Government may, by notification, appoint.

2. Chapter X of the Presidency Small Cause Courts Omission of Act, 1882 (Central Act XV of 1882) (hereinafter referred Chapter X, Central Act to as the principal Act) shall be omitted.

3. The Fourth and Fifth Schedules to the principal Omission of Act shall be omitted. the Fourth and

4. In the Code of Civil Procedure, 1908 (Central Act V to Control Act of 1908), in the First Schedule, in Order LI, in rule 1, XV of 1882. for the expression "and rule 4 of Order XXVI", the expression "rule 4 of Order XXVI and Order XXXIII" Amendment of shall be substituted. of 1908.

5. In section 2 of the Tamil Nadu Court-fees and Suits Amendment of Valuation Act, 1955 (Tamil Nadu Act XIV of 1955), section 2. in sub-section (1), clause (a) shall be omitted and the Tamil Nadu provisions of the said Tamil Nadu Court-fees and Suits Act XIV of 1955. Valuation Act, 1955 shall apply to proceedings in the Presidency Court of Small Causes, Madras.
