

Part IV-Section' 2

Tamil Nadu Acts and Ordinances.

The following Act of the Tamil Nadu Legislature received the assent of the President on the 2nd September 1985 and is hereby published for general information :--

ACT No. 42 OF 1985.

An Act to provide for the extension of the ordinary original civil jurisdiction of the Madras High Court to certain areas.

BE it enacted by the Legislature of the State of Tamil Nadu , in the Thirty-sixth Year of the Republic of India as follows :----

1. Short title and saving—(1) This Act may be called the Madras High Court (Jurisdictional Limits) Extension Act, 1985.

(2) Nothing in this Act shall affect any suit or other legal proceeding pending in any court at the date of the commencement of this Act.

2. Extension of ordinary original civil jurisdiction of Madras High Court.—Notwithstanding anything contained in the Madras High Court (Jurisdictional Limits) Act, 1927 (Tamil Nadu Act IV of 1927) or any other law for the time being in force,

the ordinary original civil jurisdiction of the High Court of Judicature at Madras shall also extend to the areas comprised in the revenue villages specified in the Schedule.
