**MADHYA PRADESH ACT**[No. 24 of 1960]<sup>1</sup>**THE MADHYA PRADESH EVACUEE INTEREST (SEPARATION)****SUPPLEMENTARY ACT, 1960**

(Received the assent of the Governor on the 4th November 1960, assent first published in the "Madhya Pradesh Gazette" on the 11th November 1960.)

An Act further to supplement certain provisions of the Evacuee Interest (Separation) Act, 1951, in their application to the State of Madhya Pradesh.

Be it enacted by the Madhya Pradesh Legislature in the Eleventh Year of the Republic of India as follows:—

1. (1) This Act may be called the Madhya Pradesh Evacuee Interest (Separation) Supplementary Act, 1960.

Short title and extent.

(2) It shall extend to the whole of Madhya Pradesh.

2. The Evacuee Interest (Separation) Amendment Act, 1960 (No. 27 of 1960), shall, in so far as it relates to any matter enumerated in List II of the Seventh Schedule to the Constitution, be as valid in the State of Madhya Pradesh as if the provisions contained therein had been enacted by the Legislature of the State.

Application of Evacuee Interest (Separation) Amendment Act, 1960 to the State.

3. The Madhya Pradesh Evacuee Interest (Separation) Supplementary Ordinance, 1960 ( 5 of 1960), is hereby repealed.
