GUJARAT ACT No. XIV OF 1961.—An Act to amend the Bombay District Municipal Act, 1901 as applied to the Saurashtra area and the Bombay Municipal Boroughs Act, 1925 as applied to the Saurashtra and Kutch areas of the State of Gujarat.

The following Act of the Gujarat Legislature, having been assented to by the Governor on the 24th April 1961 is hereby published for general information.

GUJARAT ACT No. XIV OF 1961

(First published, after having received the assent of the Governor in the "Gujarat Government Gazette" on the 29th April 1961).

An Act to amend the Bombay District Municipal Act, 1901 as applied to the Saurashtra area and the Bombay Municipal Boroughs Act, 1925 as applied to the Saurashtra and Kutch areas of the State of Gujarat.

It is hereby enacted in the Twelfth Year of the Republic of India as follows:—

1. This Act may be called the Bombay District Municipal (Saurashtra short title. Area) and Bombay Municipal Boroughs (Saurashtra and Kutch Areas) (Gujarat Amendment) Act, 1961.

Amendment of section 179 of Bom. to the Saurashtra area of the Gujarat State in sub-section (1) of section 179, 111 of 1901 the following words and figures shall be added at the end, namely:—

as applied to Saurashtra area,

"Such period may be longer than the term for which the councillors of the municipality would have held office under section 17, if the municipality had not been superseded under this section.".

Amendment of section 3. In the Bombay Municipal Boroughs Act, 1925 as adapted and applied XVIII 219 of Bom. to the Saurashtra area of the Gujarat State and that Act as extended to of XVIII of the Kutch area of the Gujarat State in sub-section (1) of section 219, the 1925. as following words and figures shall be added at the end, namely:—

Saurashtra and Kutch areas.

"Such period may be longer than the term for which the councillors of the municipality would have held office under section 24 or 25, if the municipality had not been superseded under this section."
