#### GUJARAT ACT No. XXIII OF 1961

(First published, after having received the assent of the President in the "Gujarat Government Gazette" on the 18th May 1961.)

An Act to extend the Bombay enactments which amend the Press and Registration of Books Act, 1867, throughout the State of Gujarat.

It is hereby enacted in the Twelfth Year of the Republic of India as follows :--
