#### GUJARAT ACT No. XXIII OF 1961

*(First published, after having received the assent of the President in the "Gujarat Government Gazette" on the 18th May 1961.)*

An Act to extend the Bombay enactments which amend the Press and Registration of Books Act, 1867, throughout the State of Gujarat.

It is hereby enacted in the Twelfth Year of the Republic of India as follows :—

1. (1) This Act may be called the Press and Registration of Books (Extension of Bombay Amendments) Act, 1961.

Short title and commencement.

(2) It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.

Extension of Bom. LXI of 1948 and Bom. VI of 1951 to rest of Gujarat State.

2. The Press and Registration of Books (Bombay Amendment) Act, 1948 and Press and Registration of Books (Bombay Amendment) Act, 1951, which amend the Press and Registration of Books Act, 1867, in its application to the Bombay area of the State of Gujarat, are hereby extended to, and shall also be in force in, that part of the State of Gujarat to which they did not extend immediately before the commencement of this Act.
