GUJARAT ACT No. XXIV OF 1961

(First published, after having received the assent of the President in the "Gujarat Government Gazette" on the 2nd June 1961.)

An Act further to amend the Saurashtra Estates Acquisition Act, 1952.

It is hereby enacted in the Twelfth Year of the Republic of India as follows:—

1. This Act may be called the Saurashtra Estates Acquisition short title (Gujarat Amendment) Act, 1961.

"4C (1) A tenant or moregagee-in-possession, who, though entitled to acquire the occupancy rights in a village site land and purchase the superstructure thereon under section 4A, has failed to make an application under sub-section (2) of that section within the period specified therein, may, notwithstanding the expiry of such period, make an application for acquiring occupancy rights in the village site land and for purchasing the superstructure within a period of one year from the date of the commencement of the Saurashtra Estates Acquisition (Gujarat Gui. Amendment) Act, 1961.
