#### GUJARAT ACT NO. XII OF 1962

(First published, after having received the assent of the President in the "Gujarat Government Gazette" on the 3rd March 1962.)

An Act to amend the Bombay Judicial Proceedings (Regulation of Reports) Act. 1955 for the purpose of extending it to, and bringing it into force in the rest of the State of Gujarat,

It is hereby enacted in the Twelfth Year of the Republic of India as follows:----

1. (1) This Act may be called the Bombay Judicial Proceedings (Regulation Short title of Reports) (Gujarat Extension and Amendment) Act, 1961.
