GUJARAT ACT NO. 22 OF 1968

(First published, after having received the assent of the President in the "Gujarat Government Gazette" on the 19th November 1968.)

An Act further to amend the Bombay Tenancy and Agricultural Lands (Vidarbha Region and Kutch Area) Act, 1958 in its application to the Kutch area of the State.

It is hereby enacted in the Nineteenth Year of the Republic of India as follows :---

1. (1) This Act may be called the Bombay Tenancy and Agricultural Lands Short (Vidarbha Region and Kutch Area) (Gujarat Amendment) Act, 1968.

(2) It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.

further to amend the Bombay Tenancy and Agricultural Lands Act, 1948 and the Bombay Tenancy and Agricultural Lands (Vidarbha Region and Kutch Area) Act, 1958.

It is hereby enacted in the Sixty-second Year of the Republic of India as follows:-

This Act may be called the Gujarat Tenancy and Agricultural Lands Short title. 1. Laws (Second Amendment) Act, 2011.
