#### GUJARAT ACT NO. 13 OF 1970.

(First published, after having received the assent of the President in the "Gujarat Government Gazette" on the 24th December 1970.)

An Act further to amend the Pharmacy Act, 1948 in its application to the State of Gujarat.

It is hereby enacted in the Twenty-first Year of the Republic of India as follows:—

- 1. This Act may be called the Pharmacy (Gujarat Amendment) Act, 1970. Short title,
- 2. In section 19A of the Pharmacy Act. 1948 in its application to the State Amendment of Gujarat, in sub-section (3), for the words "five years" the words "seven years" of act No. 8 shall be, and shall be deemed always to have been, substituted.
