### GUJARAT ACT NO. 7 DF 1986,

(First published, after having received the assent of the Governor in the "Gularat Government Gazette" on the 21st February, 1986).

An Act to provide for extension of term of the Executive Council of the Gujarat University.

It is hereby enaoted in the Thirty-seventh Year of the Republic of India as follows :---

1. (1) This Act may be called the Gujarat University (Extension of Term of Executive Council) Act, 1986.
