BOMBAY ACT No. L OF 1948.1

[THE INDIAN TRAMWAYS (BOMBAY AMENDMENT) ACT, 1948.]

[29nd October 1948]

Adapted and modified by the Adaptation of Laws Order, 1950.

An Act to amend the Indian Tramways act, 1886, in its application to the Province of Bombay.

- WHEREAS it is expedient to amend the Indian Tramways Act, 1886, in its application to the Province of Bombay, for the purposes hereinafter appearing; It is hereby enacted as follows:—
 - 1. This Act may be called the Indian Tramways (Bombay Amendment) Act, Short title.
 - XI of 2. In sub-section (1) of section 7 of the Indian Tramways Act, 1886, hereinafter Amendment 1886. called the said Act, after the words "public traffic" the words "or private use, of Act XI of as the case may be" shall be inserted.
 - 3. In clause (c) of sub-section (1), and in sub-section (2), of section 10, and Amendment of sections 10 in section 12, of the said Act, after the words "public traffic", the words "or private and 12 of Act use" shall be inserted.
 - 4. After section 48 of the said Act, the following new section shall be inserted, Insertion of new section analy:—

 4. After section 48 of the said Act, the following new section shall be inserted, Insertion of new section 49 in Act XI of 1886.
 - "49. Notwithstanding anything contained in this Act, the ²[State] Govern-Application ment may, by notification in the Official Gazette, exempt any tramway, which is tramways for not, or when completed will not be, ³[a railway as defined in article 366 of the Con-private use. stitution], and which is constructed and maintained for private use, from the operation of any provisions of this Act or declare that any provisions of this Act shall apply to such tramway with such modifications as may be specified in the notification."
