# An Act to amend the Press and Registration of Rooks Act, 1867, in its application to the Province of Bombay.

XXV WHEREAS it is expedient to amend the Press and Registration of Books Act, of 1867, in its application to the Province of Bombay, for the purposes hereinafter appearing : It is hereby enacted as follows :---

1. This Act may be called the Press and Registration of Books (Bombay Short title.' Amendment) Act, 1948.

(a) to the marginal note, the words "and to notified libraries" shall be added ; and

(b) after the first paragraph, the following new paragraph shall be inserted, namely :---

"Such number of copies of the book not exceeding five shall also be delivered by the printer, free of expense, to such public libraries as the Provincial Government may, by notification in the *Official Gazette*, from time to time specify, within one calendar month after the day on which any such book shall first be delivered out of the press."

3. In section 10 of the said Act, after the word "officer" the words "or the Amendment person in charge of the library, as the case may be, "shall be inserted. of Act XXV

4. In section 16 of the said Act,---

(b) for the word "second" the word "third" shall be substituted.
