### [THE BOMBAY DISTRICT MUNICIPAL AND MUNICIPAL BOROUGHS (Amendment) Act, 1951.]

[27th November 1951]

#### An Act to amend the Bombay District Municipal Act, 1901, and the Bombay Municipal Boroughs Act, 1925.

Bom. WHEREAS it is expedient to amend the Rombay District Municipal Act, 1901, 111 and the Bombay Municipal Boroughs Act, 1925, for the purposes hereinafter 1901. appearing; It is hereby enacted as follows :---

XVIII of 1. This Act may be called the Bombay District Municipal and Municipal Boroughs short title. <sup>1925.</sup> (Amendment) Act, 1951.

## 2-5. [The amendments made by sections 2-5 have been incorporated in the Bombay District Municipal Act, 1901, and the Bombay Municipal Boroughs Act, 1985.]

6. The enactment specified in the first column of the Schedule shall, in its Amendment application to the State of Bombay, be amended to the extent specified in the second of enactment column thereof.
