An Act to repeal certain enactments and to amend certain other enactments.

WHEREAS it is expedient to repeal certain enactments and to amend certain other enactments for the purposes hereinafter appearing ; It is hereby enacted in the Twenty-seventh Year of the Republic of India as follows :--

1. This Act may be called the Maharashtra Repealing and Amending Act, 1976. Short title.

2. The enactments specified in the First Schedule are hereby repealed to the Repeal of certain extent mentioned in the fourth column thereof. enactments.
