An Act to amend the Maharashtra Fiscal Responsibility and Budgetary Management Act, 2005.

WHEREAS it is expedient to amend the Maharashtra Fiscal Mah. Responsibility and Budgetary Management Act, 2005, for the XVI purposes hereinafter appearing; it is hereby enacted in the Fifty-2005. seventh Year of the Republic of India as follows:--

This Act may be called the Maharashtra Fiscal Responsibility Short title. and Budgetary Management (Amendment) Act, 2006.

2. In section 3 of the Maharashtra Fiscal Responsibility and Mah. Budgetary Management Act, 2005 (hereinafter referred to as "the XVI XVI of principal Act"), in sub-section (1), for the portion beginning with $\frac{01}{2005}$. 2005. the words "The State Government" and ending with the words "grants, namely:—" the following shall be substituted, namely:—

"The State Government shall lay, in the Budget Session of each financial year, before both Houses of the State Legislature, the following statements of fiscal policy, namely:—".

Amendment of section 4 of Mah.

3. In section 4 of the principal Act, in sub-section (2), for the portion beginning with the words "at the time" and ending with the words "for grants," the words, brackets and figures "at the time of laying the fiscal policy statements referred to in sub-section (1) of section 3," shall be substituted.
