ORISSA ACT II OF 1937.

THE MADRAS ESTATES LAND (ORISSA AMENDMENT) ACT, 1937.

[The Assent of the Governor to the Act was published in the Orissa Gazette of the 29th October 1937.]

AN ACT TO AMEND THE MADRAS ESTATES LAND (AMENDMENT) ACT, 1934, IN ITS APPLICATION TO ORISSA.

WHEREAS it is expedient to amend the Madras Estates Land (Amendment) Act, 1934, in its application to Orissa for the purpose hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement.

1.(1) This Act may be called the Madras Estates Land (Orissa Amendment) Act, 1937.

Madras Act VIII of 1934.

(2) It shall come into force at once.

Amendment of Madras Act VIII of 1934.

(2) (1) In sub-section (2) of section 127 of the Madras Estates of section 127 Land (Amendment) Act, 1934, for the expression "1st day of October 1937" in both the places where it occurs the expression "1st day of April 1938" shall be substituted and shall be deemed always to have been substituted.

Madras Act VIII of 1934.

(2) At the end of the said section 127 the following provisos shall be added, namely:-

"Provided also that, notwithstanding anything contained herein, no suit or proceedings instituted in a Revenue Court, or transferred to such Court in pursuance of the third proviso of this sub-section, involving the recovery of rent payable for any land in an inam village shall be stayed, and no order or decision in such suit or proceedings shall be construed to the prejudice of a decision that may be taken on or after the 1st day of April 1938, affecting the right, title and interest in the Kudivaram in such land;

Provided further that a party to any suit or proceedings involving recovery of rent pending in a Civil Court before the commencement of the Madras Estates Land (Orissa Amendment) Act, 1937, shall have the option of getting such suit or proceedings transferred from the Civil Court to a Revenue Court having local jurisdiction on application to the Civil Court concerned."
