further to amend the U. P. Panchayat Raj Act, 1947 and the Uttar Pradesh Kshettra  
Samitis and Zila Parishads Adhiniyam, 1961.

It is hereby enacted in the Twenty-first Year of the Republic of India as  
follows :—

1. This Act may be called the Uttar Pradesh Gaon Panchayats and Kshettra  
Samitis (Extension of Term) Act, 1970.

Short title.

2. In the U. P. Panchayat Raj Act, 1947, in section 12, in sub-section (2),  
for the words "ten years", the words "eleven years" shall be substituted.

3. In the Uttar Pradesh Kshettra Samitis and Zila Parishads Adhiniyam,  
1961, in section 8, in sub-section (1), in the first proviso thereto, for the words  
"three years", the words "four years", shall be substituted.

4. The U. P. Gaon Panchayats and Kshettra Samitis (Extension of Term)  
Ordinance, 1970 is hereby repealed.
