## THE UTTAR PRADESH ESSENTIAL SERVICES MAINTENANCE (AMENDMENT) ACT, 1982

(U. P. ACT NO. 16 OF 1982)

(As passed by the Uttar Pradesh Legislature)

#### AN ACT

to amend the Uttar Pradesh Essential Services Maintenance Act, 1966

IT IS HEREBY enacted in the Thirty-third Year of the Republic of India as follows :-

Short title and 1. (1) This Act may be called the Uttar Pradesh Essential Services commencement. Maintenance (Amendment) Act, 1982.

(2) It shall be deemed to have come into force on December 1, 1981.

2. In section 2 of the Uttar Pradesh Essential Services Maintenance Act, 1966, hereinafter referred to as the principal Act, in clause (a), for subclause (ii), the following sub-clause shall be substituted, namely-

"(ii) any service under an educational institution recognised by the Director of Education, or by the Board of High School and Intermediate Education, Uttar Pradesh, or service under a University incorporated by or under an Uttar Pradesh Act including any affiliated college, associated college, autonomous college, constituent college or Institute of any such University."

3. (1) The Uttar Pradesh Essential Services Maintenance (Amendment) Ordinance, 1982 is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken under the provisions of the principal Act as amended by the Ordinance referred to in sub-section (1), shall be deemed to have been done or taken under the corresponding provision of the principal Act as amended by this Act, as if the provisions of this Act were in force at all material times.

# AN

further to amend the Uttar Pradesh Essential Services Maintenance Act, 1966 IT IS HEREBY enacted in the Thirty-fourth Year of the Republic of Irdia as follows :--

1. (1) This Act may be called the Uttar Pradesh Essential Services Maintenance (Amendment) Act, 1983.

(2) It shall be deemed to have come into force on July 2, 1983.

short title and commencement.

2. In section 2 of the Uttar Pradesh Essential Services Maintenance Act, 1966, hereinafter referred to as the principal Act, in clause (a), after subclause (iii), the following sub-clauses shall be inserted, namely—

"(iv) any service in-connection with the U. P. State Co-operative Land Development Bank or any other State Level Co-operative Society, mentioned in clause (a-4) of section 2 of the Uttar Pradesh Co-operative Societies Act, 1965, or its member co-operative societies, registered under the said Act :

(v) any service in connection with any Government Company, in which not less than fifty-one per cent paid up share capital is held by the State Government, or any other statutory body (by whatever name called) established or constituted by or under any Uttar Pradesh Act ;

(vi) any other service connected with matters with respect to which State Legislature has power to make laws and which the State Government, being of opinion that strikes therein would prejudicially affect the maintenance of any public utility service, the public safety or the maintenance of supplies and services necessary for the life of the community or would result in the infliction of great hardship on the community, may, by notification declare to be essential service for the purpose of the Act."

3. (1) The Uttar Pradesh Essential Services Maintenance (Amendment) Ordinance, 1983, is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken under the provisions of the principal Act as amended by the Ordinance referred to in sub-section (1), shall be deemed to have been done or taken under the corresponding provisions of the principal Act as amended by this Act, as if the provisions of this Act were in force at all material times.
