In pursuance of the provisions of clause (3) of Article 348 of the Constitution of India, the Governor is pleased to order the publication of the following English translation of the Uttar Pradesh Lok Sewa (Pichhde Vargon Ka Arakshan) Adhiniyam, 1989 (Uttar Pradesh Adhiniyam Sankhya 21 of 1989) as passed by the Uttar Pradesh Legislature and assented to by the Governon on October 5, 1989.

THE UTTAR PRADESH PUBLIC SERVICES (RESERVATION FOR BACKWARD CLASSES) ACT, 1989

(U. P. ACT NO. 21 OF 1989)

ACT

to provide for the reservation of appointments or posts in favour of backward classes of citizens and to validate certain appointments.

IT IS HEREBY enacted in the Fortieth Year of the Republic of India as follows :--

(1) This Act may be called the Uttar Pradesh Public Services 1: (Reservation for Backward Classes) Act, 1989.

(2) It shall be deemed to have come into force on August 20, 1977.

Reservation of (1) In public services and posts in connection with the affairs of posts in favour of backward the State there shall be reserved the following percentages of posts at the stage of direct recruitment in favour of backward classes of citizens specified classes in the Schedule,-

(i) fifteen per cent in Group A, Group B and Group C Posts;

(ii) ten per cent in Group D posts.

(2) In this section groups A, B, C and D mean the groups of posts respectively falling in the said groups under the orders of the State Government for the time being in force.

3. Notwithstanding any judgement, decree or order of any court, any appointment of the members of backward classes of citizens specified in the Schedule to any post or service in connection with the affairs of the State made in pursuance of any rules or Government orders providing for reservation for such class shall be deemed to have been made under the provisions of this Act and shall be deemed to have always been valid.

4. (1) The Uttar Pradesh Public Services (Reservation for Backward U.P. Ordi. Ince No. Classes) Ordinance, 1989, is hereby repealed.

(2) Notwithstanding such repeal, anything done / or any action taken under the provisions of the Ordinance referred to in sub-section (1), shall be deemed to have been done or taken under the corresponding provisions of this Act, as if the provisions of this Act were in force at all material times.
