## ROMBAY ACT No. II OF 1864.1

[THE BOMBAY STEAM-VESSELS ACT, 1864.]1

[22nd September 1864]

Repealed (except section 15), by Act 6 of 1884.

An Act to provide for the periodical survey of steam-vessels in the ports, harbours, rivers or waters of the Presidency of Bombay.

PREAMBLE. [Rep. Act VI of 1884.]

1 to 14. [Survey of Steam-vessels.] Rep. Act VI of 1884.

15. It is hereby declared that sections 292, 293 and 294 of the Merchant Shipping Sections of Act (17 & 18 Vict., cap. 104)<sup>3</sup>, and Schedule S of that Act are and shall be applicable Shipping to all steam-vessels proceeding to sea from any port or place in the Presidency Act, 1854, of Bombay or its Dependencies, and that, in calculating the penalties mentioned applied to steam-vessels in the said section 293, ten rupees be taken as the equivalent for one pound proceeding to see from sterling.
