An Act to consolidate and amend the law relating to the District and Subordinate Civil Courts in the Presidency of Bombay.

WHEREAS it is expedient to consolidate and amend the law relating to the Preamble. district and other subordinate Civil Courts in the Presidency of Bombay; It is hereby enacted as follows :--

PART I.

PRELIMINARY.

11. (1) This Act may be called the Bombay Civil Courts Act. 1869. Short title (2) It extends to the whole of the State of Bombay]. and extent.

2. [Repeal of enactments.] Rep. Act XIV of 1870.

Savings. of this Act shall not have any effect in respect of and apply to-

(a) any suit of proceeding of a civil nature, whereon the subject matter exceeds in amount or value five thousand rupees but not ten thousand rupees, pending in any Court on the date on which this Act comes into force. Any such suit or proceeding shall be continued and disposed of as if this Act had not been passed; and

(b) (i) any appeal which is filed from an original or an appellate decree or order passed in any suit or proceeding wherein the subject matter is of the amount or value specified in clause (a) and which is pending in any Court on the date on which this Act comes into force;

(ii) any appeal which may hereafter be filed from such decree or order passed before the date on which this Act comes into force.

Any such appeal shall be continued or filed and disposed of as if this Act had not been passed. "

Except as provided in sections 16, 17 and 26, the District Court shall be the Appellate Court of Appeal from all decrees and orders passed by the subordinate Courts from jurisdiction which an appeal lies under any law for the time being in force which an appeal lies under any law for the time being in force. The District Judge shall have general control over all the Civil Courts and Control and 9 their establishments within the district, and it shall be his duty to inspect, or to inspection of cause one of his assistants to inspect, the proceedings of all the Courts subordinate Courts. to him, and to give such directions with respect to matters not provided for by law as he may think necessary.

The District Judge shall also refer to the High Court all such matters as appear to him to require that a rule of that Court should be made thereon.

The District Judge shall obey all writs, orders or processes issued to him by Writs and 10. the High Court, and shall make such returns or reports thereto under his signaturer orders. and the seal of the Court as the exigencies of the case require.

He shall further furnish such reports and returns and copies of proceedings as Reports and may be called for by the High Court or the "["[State] Government].

12. The 1[2[State] Government] may 3* *appoint in any District a Joint * Power to appoint Joint Judge who shall be invested with co-extensive powers and a concurrent jurisdiction Judges, with the District Judge, except that he shall not keep a file of civil suits and shall

transact such civil business only as he may receive from the District Judge, or as may have been referred to the Joint Judge by order of the High Court.

Where the Assistant Judge's decrees and orders in such cases are appealable, the appeal shall lie to the District Judge or to the High Court according as the amount or value of the subject-matter does not exceed or exceeds 1[twenty-five thousand rupees]
