# An Act to repeal the Bombay Hindu Women's Rights to Property (Extension Agricultural Land) Act, 1942, and to re-enact section 2 thereof.

1942.

1. (1) This Act may be called the Bombay Hindu Women's Rights to Property Short title, (Extension to Agricultural Land) Act, 1947.

(2) It extends to the Province of Bombay.

Bom. 2. The Bombay Hindu Women's Rights to Property (Extension to Agricultural Repeal of Bom. XVII Land) Act, 1942, is hereby repealed. of 1942.

Bom. 3. The term "Property" in the Hindu Women's Rights to Property Act, 1937, Term "pro-XVIII and the Hindu Women's Rights to Property (Amendment) Act, 1938, as in force Acts of in the Province of Bombay, shall include, and shall be deemed always to have No.XVIII of 1937 and XI of included, agricultural land: 1938.

Provided that nothing in this Act shall affect any rule of succession prescribed for land. tenants' rights in agricultural land by any special law for the time being in force.
