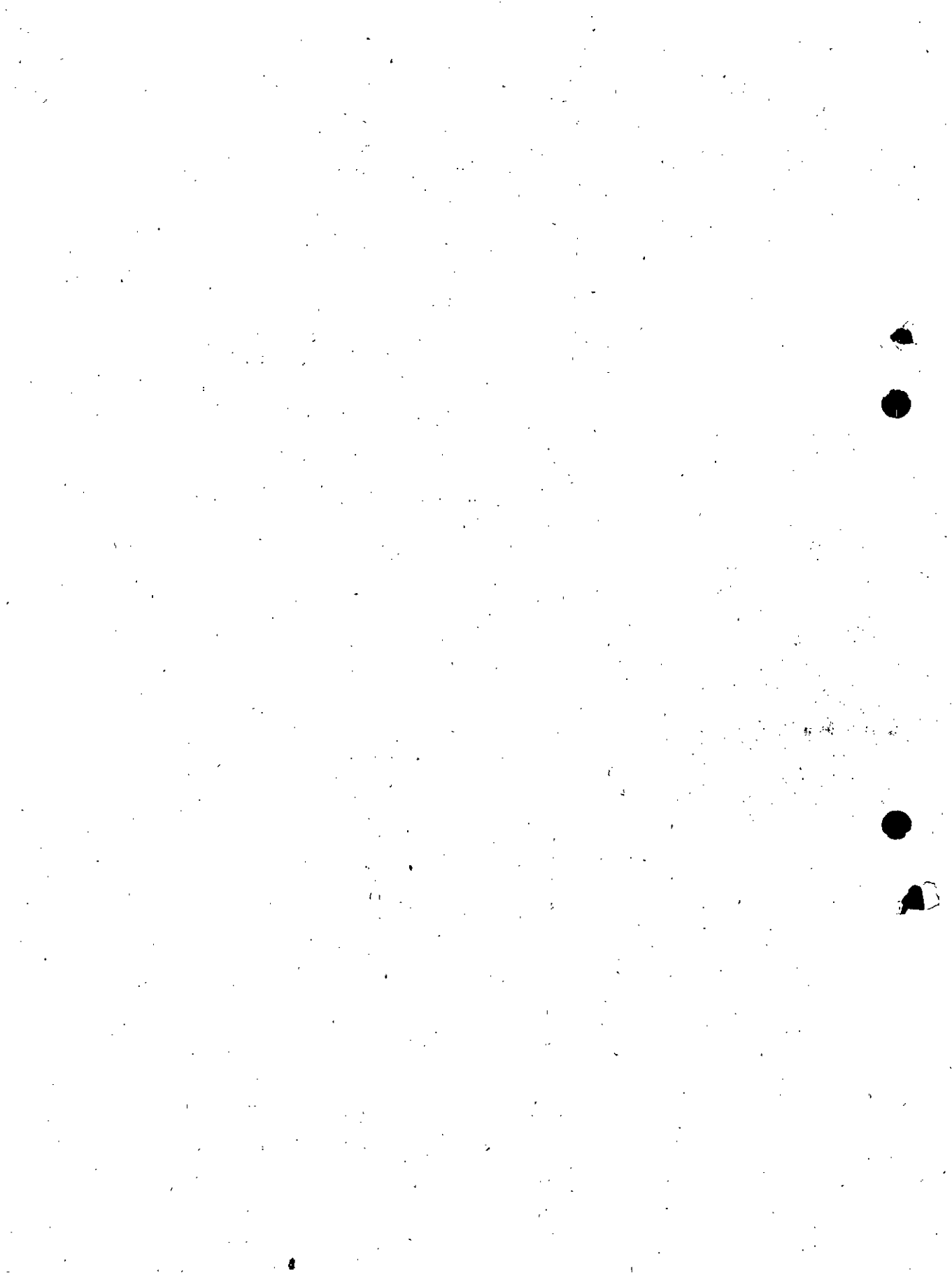

WHEREAS it is expedient to amend the Hyderabad Agricultural Debtors Relief Act, 1956, for the purpose hereinafter appearing ; It is hereby enacted in the Eighth Year of the Republic of India, as follows :—

1. This Act may be called the Hyderabad Agricultural Debtors Relief (Bombay Short title. Amendment) Act, 1957.

2. In section 4 of the Hyderabad Agricultural Debtors Relief Act, 1956, for sub-section (1), the following shall be substituted, namely :—

“(1) Any debt ordinarily residing in any local area within the Hyderabad are of the State of Bombay, or his creditor, may make an application on or before the 31st May 1957, to the Court for the adjustment of his debts.”
