An Act to provide for uniformity in the provisions of the Lepers Act, 1888, in its application to the State of Bombay.

III of WHEREAS the Lepers Act, 1898 extends to the whole of the State of Bombay
1898. except the territories which, immediately before the 1st November 1956, were comprised in Part B States ;

AND WHEREAS in the Hyderabad area of the State of Bombay there exists the Hyd. Hyderabad Leprosy Act, 1953 but in the Saurashtra area there is no such iv of corresponding Act;

111 of AND WHEREAS the Lepers Act, 1898 has been amended in its application to the 1898. pre-Reorganisation State of Bombay, excluding the transferred territories;

AND WHEREAS it is expedient to provide for uniformity in the provisions of the Lepers Act, 1898. in its application to the State of Bombay, and for that purpose to extend to the rest of the State of Bombay that Act as in force in the pre-Reorgani-

Hyd. sation State of Bombay, excluding the transferred territories and to repeal the IV of Hyderabad Leprosy Act, 1953;

It is hereby enacted in the Tenth Year of the Republic of India as follows :----

1. This Act may be called the Lepers (Bombay Unification) Act, 1959.

Short title.

III of 2. (1) The Lepers Act, 1898 as amended by the Lepers (Bombay Amendment) Extension of 1898. Act, 1955 is hereby extended to the Hyderabad and Saurashtra areas of the State Act III of 1898 and XXV. of Bombay. III of 1955

Bom. (2) The Lepers (Bombay Amendment) Act, 1955 is hereby extended to the state. XXV-Vidarbha region and Kutch area of the State of Bombay to which it did not extend 1955. immediately before the commencement of this Act ; and the Lepers Act, 1898 III of shall, on such commencement, be deemed to be amended by it in that part of the 1898. State also.

1898 to sub-section (2) the following proviso shall be added, namely :--

Bom. "Provided that on the commencement of the Lepers (Bombay Unification) XXX: IX of 1959. Act, 1959, it shall also extend to the Hyderabad and Saurashtra areas of the State of Bombay."
