WHEREAS it is expedient further of supplement certain provisions of the Evacuee Interest (Separation) Act, 1951, in its application to the State of Maharashtra, for the purpose hereinafter appearing; It is hereby enacted in the Eleventh Year of the Republic of India as follows:-

1. (1) This Act may be called the Maharashtra Evacuee Interest (Separation) short title, Supplementary Act, 1960.

- (3) It shall be deemed to have come into force on the 15th day of October 1960.
