An Act to amend the Wakf Act, 1954, in its application to the State of Maharashtra.

**XXIX** WHEREAS it is expedient to amend the Wakf Act, 1954, in its application to  
of 1954. the State of Maharashtra, for the purposes hereinafter appearing; It is hereby  
enacted in the Sixteenth Year of the Republic of India as follows:—

1. This Act may be called the Wakf (Maharashtra Amendment) Act, 1965. Short title.

**XXIX** 2. In the Wakf Act, 1954, in its application to the State of Maharashtra (herein-  
of 1954. after referred to as "the principal Act"), in section 10, for sub-section (2), the  
following shall be substituted, namely:— Amendment  
of section 10

"(2) There shall be a Chairman of the Board who shall be nominated by the State Government from amongst the members appointed under section 11."

3. In section 63 of the principal Act,—

(a) for the words "the State Government may," the words "the State Govern-  
ment or any officer authorized by the State Government may," shall be  
substituted; Amendment  
of section 63  
of Act

1954.

(b) after the words "as the State Government" the words "or officer" shall  
be inserted; and

(c) in the marginal note, for the words "the State Government" the following  
shall be substituted, namely:—

"State Government or officer"

4. In section 67 of the principal Act, in sub-section (2), in clause (b), after  
the words "submitted by the Board" the words "and approved by the State  
Government" shall be added. Amendment
