

MAHARASHTRA ACT No. XIV OF 19831

[THE ADMINISTRATORS-GENERAL AND OFFICIAL TRUSTEES (MAHARASHTRA AMENDMENT) ACT, 1982.]

[This Act received assent of the President on the 24th February 1983; assent was first published in the *Maharashtra Government Gazette*, Part IV, Extraordinary, on the 1st March 1983.]

An Act to amend the Administrators-General Act, 1963 and the Official Trustees Act 1913, in their application to the State of Maharashtra.

XLV WHEREAS it is expedient to amend the Administrators-General Act, 1963 and of the Official Trustees Act, 1913, in their application to the State of Maharashtra, for 1963, the purpose hereinafter appearing; It is hereby enacted in the Thirty-third Year 1913, of the Republic of India as follows:—

- 1. (1) This Act may be called the Administrators-General and Official Trustees Short title (Maharashtra Amendment) Act, 1982.
- (2) it shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint.
- XLV 2. To section 43 of the Administrators-General Act, 1963, in its application to Amendment of the State of Maharashtra, the following proviso shall be added, namely:—

"Provided that, notwithstanding anything contained in the Bombay Local of 1913. Fund Audit Act, 1930, the State Government may, by order published in the Official Gazette, direct that all or any of the accounts of the Official Trustee for the State, for such period or periods, and in such manner, as may be specified in the order, shall be audited by an officer or officers deputed by the Chief Auditor, Local Fund Accounts, and shall be certified by him or them as provided in subsection (2)."
