MAHARASHTRA ACT No. XV OF 1997.1

(This Act received the assent of the President on 16th January 1997; assent first published in the *Maharashtra Government Gazette*, Part-IV, Extraordinary, on 17th January 1997.)

An Act to make provision for constitution of a Maritime Board for minor ports in the State of Maharashtra and to vest administration, control and management of such ports in that Board and to provide for matters connected therewith and incidental thereto.

WHEREAS it was expedient to make provisions for the constitution of a Maritime Board for minor ports in the State of Maharashtia and to vest administration, control and management of such ports in that Board and to provide for matters connected therewith and incidental thereto;

AND WHEREAS both Houses of the State Legislature were not in session;

AND WHEREAS the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate action to make a law for the purposes aforesaid; and, therefore, promulgated the Maharashtra Maritime Mah. Board Ordinance, 1996, on the 4th October 1996;

of AND WHEREAS it is expendient to replace the said Ordinance by an Act of State 1996. Legislature; It is hereby enacted in the Forty-seventh Year of the Republic of India as follows:—

CHAPTER 1 PRELIMINARY.

- 1. (1) This Act may be called the Maharashtra Maritime Board Act, 1996.
- (2) It extends to the whole of the State of Maharashtra.
- (3) It shall be deemed to have come into force on the 4th October 1996.

Short title, extent, commencement and application.

- (4) It applies to all the minor ports in the State to which the Indian Ports Act, 1908, applies on the date of the commencement of this Act and the State Government may, by notification in the Official Gazette, apply the provisions of this Act to any other minor port in the State to which the Indian Ports Act, 1908 is extended by the State Government under section 4 of that Act, and with effect from such date, as may be specified in the notification.
 - 2. In this Act, unless the context otherwise requires,—

Definitions.

- (a) "appointed day", in relation to any minor port, means the day on which this Act is made applicable to that port;
- (b) "Board" means the Maharashtra Maritime Board constituted under section 3;
- (c) "Board Security" means debentures, bonds or dock certificates issued by the Board in respect of any loan contracted by it under the provisions of this Act;
- (d) "Chairman" means the Chairman of the Board appointed under section 3 and includes the person appointed under section 9 to act as the Chairman;
- (e) "dock" includes all basins, locks, cuts, entrances, graving docks, graving blocks, inclined planes, slipways, gridirons, moorings, transit sheds, warehouses, godowns, open plots and other works and things appertaining to any dock and also the portion of the sea enclosed or protected by the arms or groynes of a harbour;

- (f) "foreshore", in relation to a port, means the area between the high water mark and the low water mark relating to that port:
 - (g) "goods" includes livestock and every kind of movable property;
- (h) "Government" or "State Government" means the Government of Maharashtra;
- (i) "high water mark", in relation to a port, means a line drawn through the highest point reached by ordinary spring tides during any season of the year at that port;
- (j) "immovable property" includes what fage-rights and all other rights exercisable on, over or in respect of any land, wharf, dock or pier;
 - (k) "Indian Ports Act" means the Indian Ports Act, 1908;

- (1) "land" includes the bed of sea or river below high water mark and also things attached to the earth or permanently fastened to anything attached to the earth;
- (m) "low water mark", in relation to a port, means a line drawn through the lowest point reached by ordinary spring tides at any season of the year at that port:
- (n) "master", in relation to any vessel or craft making use of any minor portmeans any person having for the time being in charge or control of such vessel or craft, as the case may be, except a pilot, harbour master, dock master, or berthing master of the port;
- (o) "member" means a member of the Board or its Committee, as the case may be;
 - (p) "minor port" means a port other than a major port declared as such by the Central Government under any law:
 - (q) "owner",—

(i) in relation to goods, means and includes any consignor, consignee, shipper or agent for the sale, custody, loading or unloading of such goods, and

(ii) in relation to any vessel or craft making use of any port, means and includes any port owner, charterer, consignee or mortgagee in possession thereof;

- (r) "pier" includes any stage, stair, landing place, hard jetty, floating barg or pontoon and any bridges or other works connected therewith;
- (s) "port" means any minor port to which this Act applies within such limits as may, from time to time, be defined by the State Government under the Indian Ports Act;
- (t) "port approaches", in relation to a port, means those parts of the navigable rivers and channels leading to the port in which the Indian Ports Act is in force;
- (u) "prescribed" means prescribed by rules or regulations made underisthis Act:
 - (v) "public securities" means,—
 - (i) promissory notes, debentures, stock or other securities of the Central Government or of any State Government:

Provided that, securities both the principal and the interest whereof have been fully and unconditionally guaranteed by any such Government shall be deemed, for the purposes of this clause, to be the securities of that Government; and

- (ii) debentures or other securities for money issued by or on behalf of any Municipal body, Improvement Trust or Port Trust under the authority of any law for the time being in force in the State and includes the Board Securities;
- (w) "rate" means and includes any toll, dues, rent. fee or charge leviable under this Act;

- (x) "regulations" means regulations made under this Act;
- (y) "rules" means rules made under this Act;
- (z) "State" means the State of Maharashtra:
- (za) "vessel" includes anything made for the conveyance, mainly by water, of human being or of goods;
- (zb) "wharf" includes any wall or stage and any part of the land or foreshore that may be used for loading or unloading goods for the embarkation or disembarkation of passengers and any wall enclosing or adjoining the same.

CHAPTER II

ESTABLISHMENT OF MAHARASHTRA MARITIME BOARD

- 3. (1) As soon as may be after the commencement of this Act, the Government Establishmay, *by notification in the Official Gazette, establish a Board to be called "the ment of Maharashtra Maritime Board". Maritime
- (2) The Board shall be a body corporate by the name aforesaid having perpetual Board. succession and a common seal with power to acquire, hold and dispose of property, both movable and immovable, and to contract, and may by the said name sue and he sued.
- (3) The head-office of the Board shall be at such place as the State Government may, by notification in the Official Gazette, direct.
- (4) The Board shall consist of the Chairman, the Vice-Chairman and not more than eleven other members to be appointed by the State Government, namely:—

- Disqualification of member of the Board, if he,—
 members.
 - (a) has been removed or dismissed from the service of Central or State Government or of local authority or of a corporation owned or controlled by that Government;
 - (b) has been convicted for an offence involving moral turpitude; or
 - (c) is an undischarged insolvent; or
 - (d) has directly or indirectly any share or interest in any work done by order of the Board or in any contract or employment with, by or on behalf of, the Board.

Provided that, no person shall be deemed to have share or interest in such work, contract or employment by reason only of his,—

(i) having a share in any company or firm which may contract with or be employed by or on behalf of the Board; or

(ii) having a share or interest in any newspaper in which any advertisement relating to the affairs of the Board may be inserted; or

(iii) being interested in any loan of money to the Board; or

(iv) having a share or interest in any lease, sale, exchange or purchase of immoveable property or any agreement for the same; or

(v) having a share or interest in any licence by the Board or right by agreement or otherwise with the Board, to the sole or preferential use of any premises or property belonging to the Board; or

(vi) having a share or interest in the occasional sale by the Board of a value not exceeding ten thousand rupees in any one financial year, of any article in which he trades.

Term of 5. Subject to the provisions of this Act, the non-official members of the Board office of shall hold office during the pleasure of the Government and in any case for a period not exceeding three years.

Removal of members of Board.

- 6. (1) The Government shall remove a member of the Board, if he,—
 - (a) is or has become subject to any disqualification mentioned in section 4; or

(b) refuses to act or becomes incapable of acting; or

- (c) has, in the opinion of the Government, become incapable of representing the interests by virtue of which he was appointed; or
- (d) is, without the permission of the Board previously obtained, absent from six consecutive meetings of the Board; or
- (e) is absent from the meetings of the Board for a period exceeding six consecutive months;
 - (f) acts in contravention of the provisions of section 13.
- (2) A non-official member of the Board may resign from his office by tendering his resignation in writing to the Chairman who shall forward the same to the Government, but the resignation shall not take effect until it is accepted by the Government.
- Eligibility of 7. Any person ceasing to be a member shall, unless disqualified under section appointment. 4, be eligible for reappointment.
 - Firing of 8. (1) Any vacancy in the office of the non-official members of the Board shall vacancy be filled as early as possible in the like manner as if the appointment were being made for the first time under the relevant clause:

Provided that, where any vacancy occurs in the office of any such non-official member within three months preceding the date on which the term of the office of such member expires under section 5, it shall not be filled.

- (2) A member appointed under sub-section (1) shall hold office so long only as the member in whose place he has been appointed would have held office if the vacancy had not occurred.
- 9. If the Chairman is absent on leave or otherwise, the Vice-Chairman and in Absence of the absence of both the Chairman as well as the Vice-Chairman, such person as Chairman the State Government may appoint, shall act as the Chairman.
- 10. (1) The Board shall hold meetings at such times and places and shall subject Meeting of to the provisions of sub-sections (2), (3) and (4) follow such procedure in regard to Board, the transaction of business at its meetings as provided by the regulations.
- (2) The Chairman, and in his absence the Vice-Chairman, and in the absence of both the Chairman as well as the Vice-Chairman, any person chosen by the members present from amongst themselves, shall preside at meetings of the Board.
- (3) All questions at a meeting of the Board shall be decided by a majority of the votes of the members present and voting and, in the case of equality of votes, the person presiding shall have a second or casting vote.
- (4) The number of members necessary to constitute a quorum at a meeting shall be such as may be provided in the regulations and no business shall be transacted at any meeting unless the members constituting the quorum are present throughout such meeting.
- 11. (1) The Board may, from time to time, constitute from amongst its members Committees one or more Committees, consisting of such number as the Board may consider of Board necessary, for the purpose of discharging such of its duties and functions as may be delegated to such Committee or Committees by the Board.
- (2) A Committee constituted under sub-section (1) shall meet at such time and at such place and shall follow such procedure in regard to the transaction of business at its meetings (including the quorum) as may be provided by regulations.
- 12. The non-official members shall be paid by the Board such fees and allowances Fees and for attending meetings of the Board or of any of its Committees and for attending allowances payable to any work of the Board as may be prescribed by rules:

Provided that .--

(a) no fees shall be payable to a member who is a Member of Parliament or State Legislature;

(b) any allowances payable to a member who is a Member of Parliament or 10 of State Legislature shall not exceed the compensatory allowance as defined in clause 1959. (a) of section 2 of the Parliament (Prevention of Disqualification) Act, 1959 or Bom, as the case may be, in the Explanation to entry 11 in Schedule I to the Maharashtra 1.956 Legislature Members (Reomoval of Disqualifications) Act.

- 13. A member of the Board or of a Committee thereof, who--
 - (i) has any direct or indirect pecuniary interest in any matter coming up for consideration at a meeting of the Board or a Committee thereof, or
- (ii) is interested professionally on behalf of a client or as agent for any in certain person other than the Government or an undertaking owned or controlled by the Government or a local authority or a trade union registered under the Trade Unions Act. 1926 or member of an association formed for the purpose of promoting the interest or welfare of any class of employees of the Board,

shall, as soon as possible after relevant circumstances have come to his knowledge disclose the nature of his interest at such meeting and the disclosure shall be recorded in the minutes of the meeting of the Board or, as the case may be, the Committee, and the member shall not take part in any deliberation or decision of the Board or the Committee with respect to that matter.

Defects in 14. No act or proceeding of the Board or of any of its Committees shall be appointment invalid merely by reason of,—

- (a) any vacancy therein or any defect in the constitution thereof;
- (b) any disqualification of or any defect in the appointment of, a person acting as a member thereof; or
- (c) any member having acted or taken part in any proceedings in contravention of section 13;
 - (d) any irregularity in its procedure not affecting merits of the case.

Delegation 15. The Board may, with the previous approval of the State Government, direct of powers. that such of the powers and duties conferred or imposed upon the Board by or under this Act as may be specified in such direction, may also be e xeercised or performed by the Chief Executive Officer subject to such conditions and restrictions as may be specified in such direction.

Duties of 16. (1) It shall be the duty of the Chairman, the Vice-Chairman and the Chief Chairman, Executive Officer to attend every meeting of the Board unless prevented by sickness etc. or other reasonable cause.

- (2) The Chief Executive Officer shall, as soon as possible, transmit to the Government a copy of the minutes of every meeting of the Board and shall furnish to the Government such reports, returns, documents or other information as it may, from time to time, call for.
- (3) The Chief Executive Officer shall exercise supervision and control over the acts of all employees of the Board in the matters of executive administration and in matters concerning the accounts and records of the Board.

(2) The salary, allowances and other conditions of service of the Chief Executive Officer shall be such as may be prescribed by the rules.

Financial 18. (1) The Board shall, with the previous sanction of the State Government, Controller-appoint a person possessing the qualification prescribed by rules to be the Financial cum-Chief Controller-cum-Chief Accounts Officer. The State Government may sanction such Accounts Officer, appointment on such terms and conditions as it thinks fit.

employees (2) The Board may create such other posts and appoint such other officers and of Board, employees as it considers necessary for the efficient performance of the functions of the Board and determine by regulations their conditions of appointment and service and remuneration payable to them:

Provided that, no person shall be appointed as a pilot at any port who is not for the time being authorised by the State Government under the Indian Ports Act to pilot vessels at that port.

- (3) The Board shall, from time to time, prepare and sanction a Schedule of the employees of the Board considered necessary, adequate and proper to maintain for the purposes of this Act and such Schedule shall indicate therein the designations and grades of employees and the salaries, fees and allowances which are proposed to be paid to them.
- 19. (1) Subject to any regulations, the power of granting extension of service to, power to of granting leave to, suspending, reducing, removing or dismissing or of disposing grant leave, of any other question relating to the services of the employees of the Board including etc., to the power of dispensing with the services of any such employee otherwise than by employees reason of the misconduct of such employee, shall be exercised by the Board or such authority as may be laid down by regulations.

(2) Any officer or employee of the Board aggreeved by an order involving his reduction in rank, removal or dismissal may, within such time and in such manner as may be provided for by regulations, prefer an appeal to the State Government

CHAPTER IV

PROPERTY AND CONTRACTS

20. As from the appointed day in relation to any port,—

Transfer of Government to Board.

- (a) all property, assets and funds and all rights to levy rates vseted in the State jabilities of Government for the purposes of the port, immediately before such day, shall vest State in the Board:
- (b) all debts, obligations and liabilities incurred, all contracts entered into and all matters and things engaged to be done by, with or for, the State Government immediately before such day, for or in connection with the purposes of the port shall be deemed to have been incurred, entered into and engaged to be done by, with, or for, the Board;
- (c) all non-recurring expenditure incurred by the State Government for or in connection with the purposes of the port upto such day and declared to be capital expenditure by the State Government shall be treated as the capital provided by the Government to the Board;
- (d) all rates, fees, rents and other sums of money due to the Government in relation to the port, immediately before such day, shall be deemed to be due to the Board;
- (e) all suits and other legal proceedings instituted by or against the Government immediately before such day for any matter in relation to port, may be continued by or against the Board:
- (f) every employee serving under the Government immediately before such day solely or mainly for or in connection with the affairs of the minor port shall become an employee of the Board, and shall hold his office or service therein by the same tenure and upon the same terms and conditions of service as he would have held the same if the Board had not been established and shall continue to do so unless and until his employment in the Board is terminated or until his tenure, remuneration or terms and conditions of service are duly altered by the Board :

Provided that, the tenure, remuneration and terms and conditions of service of any such employee shall not be altered to his disadvantage without the previous sanction of the Government.

As from the appointed day, all rates, fees and other charges in relation to rates etc. to any port, shall unless and until varied in accordance with the provisions of this until altered Act, continue to be levied and collected, at the same rate at which they were being by Board, levied and collected by the State Government before such day.

 - Contracts 24. With respect to the making of contracts by the Board for the purposes of by Board, this Act, the following provisions shall have effect, namely:—
 - (a) Every contract shall be made on behalf of the Board by the Chief Executive Officer or an officer authorised by the Board.
 - (b) No contract for leasing waterfront, jetty, waterway and corresponding infrastructural facilities thereof for a term exceeding five years shall be made unless it is previously approved by the Government on such terms and conditions as it may thinks fit.
 - (c) No contract for the acquisition or sale of immoveable property or for the lease of any such property for a term exceeding thirty years, shall be made unless it is previously approved by the Government, on such terms and conditions as it may thinks fit.
 - (d) The form and manner of executing contracts on behalf of the Board shall be such as may be prescribed by rules.
 - (e) No contract which is not made in accordance with the provisions of this Act and the rules shall be binding on the Board.

CHAPTER V

Works and Services to be Provided at Minor Ports by the Board

Power of 25. (1) The Board may, subject to any other law for the time being in force, Board to execute execute such works, within or without the limits of port and provide such appliances works and as it may deem necessary or expedient.

(a) Wharves, quays, docks, stages, jetties, piers, place of anchorage and other works within the port or port approaches or on the foreshore of the port or port approaches in the State, with all such convenient arches, drains, landing places, stairs, fences, reads, bridges, tunnels and approaches, and buildings required for the residence of the empolyces of the Board as the Board may consider necessary;

- (b) buses, locomotives, rolling stock, sheds, hotels, warehouses and other accommodation for passengers and goods and other appliances for carrying passengers and for conveying, receiving and storing goods landed, or to be shipped or otherwise;
- (c) moorings and cranes, scales and all other necessary means and appliances for loading and unloading of vessels;
- (d) reclaiming, excavating, enclosing and raising any part of the foreshore of the port or port approaches which may be necessary for the execution of the works authorised by this Act or otherwise for the purposes of this Act;
- (e) such breakwaters and other works as may be expedient for protection of the port;
- (f) dredgers and other machines for cleaning, widening, deepening and improving any portion of the port or port approaches or of the foreshore of the port or port approaches:
- (g) light-houses, light-ships, beacons, buoys, pilot boats and other appliances necessary for the safe navigation of the port and the port approaches in so far as it relates to State functions:
- (h) vessels, tugs, boats, barges and launches and lighters for the use within the limits of the port or beyond those limits, whether in territorial waters or otherwise, for the purpose of towing or rendering assistance to any vessel whether entering or leaving the port or bound elsewhere and for the purpose of saving or protecting life or property and for the purposes of landing, shipping or transhipping passengers or goods under section 32;
- (i) sinking of tubewells and equipment, maintenance and use of boats, barges and other appliances for the purpose of the supply of water at the port;
 - (j) engines and other appliances necessary for extinguishing of fires;
 - (k) lands abutting the sea coast including creeks;
- (1) ferry boats and other works and equipment appertaining to the running ferry service at or between the ports:
 - (m) construction of models and plans for carrying out hydraulic studies;
- (n) dry docks, slipways, boat basins and workshop to carry out repairs or overhauling of vessels, tugs, boats, machinery or other appliances.
- 26. (1) The Board may undertake to carry out on behalf of any person any Power of works or services or any class of works or services, on such terms and conditions Board to as may be agreed upon between the Board and the person concerned.

- (2) The Board may, if it considers necessary or expedient in the public interest works. so to do, lend any of its vessels or appliances or the services of any of its employees to any person for such period not exceeding three months and on such terms and condtions as may be agreed upon between the Board and the person concerned.
- 27. (1) When any dock, berth, wharf, quay, stage, jetty or pier erected at any power of port or port approaches under the provisions of this Act has been completed with Board to sufficient Warehouses, sheds and appliances for receiving, landing or shipping goods order or passengers from and upon sea-going vessels, the Board may, after obtaining the vessels to approval of the Collector of Customs and by notification published in three consecu-use docks, tive issues of the Official Gazette, declare that such dock, berth, wharf, quay, stage, wharves, jetty, pier or place of anchorage is ready for receiving, landing and shipping or for etc. janding or for shipping goods or passengers from and upon sea-going vessels.
- (2) As from the date of the publication of such notification for the third time it shall be lawful for the Board, from time to time, when there is room at such dock, berth, wharf, quay, stage, jetty or pier, to order to come alongside of such dock, berh

wharf, quay, stage, jetty, pier or place of anchorage for the purpose of landing and shipping goods or passengers or for landing or for shipping the same any sea-going vessel within the port or port approaches which has not commenced to discharge goods or passengers or which being about to take in goods or passeners has not commenced to do so:

Provided that, before making such order the Board shall have regard, as far as possible, to the convenience of such vessel and of the shippers in respect of the rule of any particular dock, berth, wharf, quay, stage, jetty, pier or place of anchorage:

Provided further that, if the Board is not the Conservator of the Port, the Board shall not itself make the order as aforesaid but shall require the Conservator of the Port or other person exercising the rights, powers and authorities of the Conservator of the Port to make such order.

28.  - (ii) while within such limits, to anchor, fasten or lie within fifty yards of the ordinary low-water mark.
- (3) If after the publication of such order, any such vessel, while within the limits so specified, so anchor, fasten or lie, it shall be lawful for the Board to cause the same to be removed out of the said limits at the expense of the master or owner or agent of the vessel.
 - 32. (1) The Board shall have power to undertake the following services:

 (a) stevedoring, landing, shipping or transhipping passengers and goods by Board between vessels in port and the wharves, piers, quays or docks belonging to or or other in the possession of the Board;
 - (b) receiving, removing, shifting, transporting, storing or delivering goods brought within the Board's premises;
 - (c) carrying passengers within the limits of the port or port approaches, by such means and subject to such restrictions and conditions as the State Government may think fit to impose; and
 - (d) piloting, hauling, mooring, remooring, hooking or measuring of vessels or any other service in respect of vessels.
- (2) The Board may, if so requested by the owner, take charge of the goods for the purpose of performing the service or services and shall give a receipt in such form as the Board may specify.
- (3) Notwithstanding anything contained in this section, the Board may authorise any person to perform any of the services mentioned in sub-section (1) on such terms and conditions as may be agreed upon.
- (4) No person authorised under sub-section (3) shall charge or recover for such service any sum in excess of the amount leviable according to the scale framed under sections 37, 38 or 40.
- (5) Any such person shall, if so required by the owner, perform in respect of the goods any of the services and for that purpose take charge of the goods and give a receipt in such form as the Board may specify.
- (6) The responsibility of any such person for the loss, destruction or deterioration 9 of of goods of which he has taken charge shall, subject to the other provisions of this 1872. Act, be that of a bailee under sections 151, 152 and 161 of the Contract Act, 1872.
 - (7) After any goods have been taken charge of and a receipt given for them under this section, no liability for any loss or damage which may occur to them shall attach to any person to whom a receipt has been given or to the master or owner of the vessel from which the goods have been landed or transhipped.

- 33. (1) Subject to the provisions of this Act, the responsibility of the Board for lity of the loss, destruction or deterioration of goods of which it has taken charge shall,-
 - (i) in the case of goods received for carriage by railway, be governed by the provisions of the Indian Railways Act, 1890, and

(ii) in other cases, be that of a bailee under sections 151, 152 and 161 of the 9 of Contract Act, 1872, omitting the words "in the absence of any special contract" 1872. in section 152 of that Act:

Provided that, no responsibility under this section shall attach to the Board,—

- (a) until a receipt mentioned in sub-section (2) of section 32 is given by the Board; and
 - (b) after the expiry of such period as may be prescribed by regulations from the date of taking charge of such goods by the Board.
- (2) The Board shall not be in any way responsible for the loss, destruction or deterioration of, or damage to, goods of which it has taken charge, unless notice of such loss or damage has been given within such period as may be prescribed by regulations made in this behalf from the date of taking charge of such goods by the Board under sub-section (2) of section 32.

- 34. (1) Where the Collector of Customs has, under the provisions of any Act Accommodation to for the levy of duties of customs, appointed any dock, berth, whart, quay, stage, be provided jetty, pier, place of anchorage, warehouse or shed or a portion of any warehouse for officers or shed provided at any port under the provisions of this Act for the use of seain wharves, going vessels to be an approved place for the landing or shipping of goods or a wareetc. house for the storing of dutiable goods on the first imports thereof without payment appointed of duty, within the meaning of the first-mentioned Act, the Board shall set apart under and maintain such place on or adjoining such dock, wharf, quay, stage, jetty, pier Act, 1962, or a place of anchorage or in such warehouse or shed or portion thereof, for the use of officers of Customs as may be necessary.
 - (2) Notwithstanding that any dock, berth, wharf, quay, stage, jetty, pier, place of anchorage, warehouse or shed or portion thereof at any port has, under the provisions of sub-section (1), been set apart for the use of the officers of customs at the port, all rates and other charges payable under this Act in respect thereof or for the storage of goods therein, shall be payable to the Board, or to such person or persons as may be appointed by the Board to receive the same.
- 35. (1) No person shall make, erect or fix within the limits of a port or port permit approaches any wharf, dock, quay, stage, jetty, pier, erection or mooring or undererection of takes any reclamation of foreshore within the said limits except with the previous wharves, etc. permission in writing of the Board and subject to such terms and conditions, if any, within limits as the Board may specify.

- of a port subject to (2) If any person makes, crects or fixes any wharf, dock, quay, stage, jetty, pier, conditions erection or mooring or undertakes any reclamation of foreshore in contravention of sub-section (1), the Board may, by notice, require such person to remove it within such time as may be specified in the notice and if the person fails so to remove it, the Board may cause it to be removed at the expense of that person.

(1) Where as a result of an order published under section 28, or section 31 tion payable in certain the use of any wharf, dock, berth, quay, stage, jetty, pier or place of anchorage, cases where made, fixed or erected by any person is rendered unlawful, the Board may, after use of any hearing the person concerned by order, close, remove, fill up or destroy such wharf, private dock, berth, quay, stage, jetty, pier or place of anchorage, or permit the use thereof wharf, etc., deek, derry, day, stage, jetty, pior of place of ancholage, or perfint the use thereof rendered to such person on payment of such rates and charges as the Board may, with the unlawful previous sanction of the State Government, determine.

- (2) Save as otherwise provided under sub-section (3), no person shall be entitled to claim compensation for any injury, damage or loss caused or alleged to have been caused by an order made under sub-section (1).
- (3) If it is proved to the satisfaction of the Board that any such wharf, dock, berth, quay, stage, jetty, pier or plac of anchorage, was made, fixed or erected by any person with the previous permission of the authority competent to grant such permission, he shall be paid by the Board compensation, the amount of which shall be determined in the manner and in accordance with the principles hereinafter set out, that is to say:—
 - (a) in computing the compensation, there shall not be taken into account any rates or other chalges which such person shall be liable to pay for using any wharf, dock, berth, quay, stage, jetty, pier or place of anchorage, provided by the Board;
 - (b) the amount of compensation shall be calculated with reference to the cost of construction of such whaif, dock, berth, quay, stage, jetty, pier or place of anchorage;

 - (e) the Government may, in any particular case, nominate a person possessing special knowledge of any matter relating to any case under inquiry to assist the arbitrator in determining any question which has to be decided by him under this section, and where such nomination is made the person to be compensated may also nominate an assessor for the same purpose;
 - (f) at the commencement of the proceeding before the arbitrator, the Board and the person to be compensated shall state what in their respective opinion is a fair amount of compensation;
 - (g) the arbitrator shall after hearing the dispute, make an award determining the amount of compensation which appears to him to be just and specify the person or persons to whom such compensation shall be paid;
 - (h) where there is a dispute as to the person or persons who are entitled to the compensation, the arbitrator shall decide such dispute and if the arbitrator finds that more persons than one are entitled to compensation he shall aportion the amount thereof among such persons;

- (i) nothing in the Arbitration and Concilliation Act, 1996 shall apply to arbitrations under this section;

 - (c) cranage or porterage of goods on any such place;
 - (d) wharfage, storage or demurrage of goods on any such place; and
- (e) any other service in respect of vessels, passengers or goods excepting the services in respect of vessels for which fees are chargeable under the Indian Ports
- (2) Different scales of rates and conditions may be framed for different classes of goods and vessels and for different ports.

- 38.  - (d) any other use of any land, building, works, vessels or appliances belonging to or provided by the Board.
 - (2) Different scales of rates and conditions may be framed for different classes of goods and vessels and for different ports.
- 39. The Board may, from time to time, frame a consolidated scale of rates for Consolidated rates of any combination of the services specified in section 37 or for any combination of combination such service or services with any use or permission to use any property belonging of services. Every scale of rates and every statement of conditions framed by the Board Prior under the foregiong provisions of this Chapter shall be submitted to the Government sanction of for sanction and shall have effect when so sanctioned and published by the Board State Government in the Official Gazette.

- 42. (1) Whenever the Government considers it necessary in the public interest Power of so to do, it may, by order in writing, direct the Board to cancel any of the scales in State force or modify the same within such period as it may specify.

- (2) If the Board fails or neglects to comply with such direction within the specified modification period, the Government may cancel any of such scales or make such modifications or cancellation therein as it may think fit:

Provided that, before so cancelling or modifying any scale the Government shall consider any objection or suggestion which may be made by the Board during the specified period.

- (3) When in pursuance of this section any of the scales has been cancelled or modified, such cancellation or modification shall be published by the Government in the Official Gazette, and shall thereupon have effect accordingly.

The Board may, in special cases, and for reasons to be recorded in writing, Remission exempt either wholly or partly any goods, vehicles, or vessels or class of goods, of rates of vehicles or vessels from the payment of any rate or of any charge leviable in respect charges. thereof according to any scale of rates in force under this Act or remit the whole o any portion of such rate or charge so levied.
- 44. No person shall be entitled to a refund of an excess charge made by the Refund of Board unless his claim to the refund has been preferred in writing by him or on his excess behalf to the Board within six months from the date of payment duly supported by charges all original relevant documents:

Provided that, the Board may, of its own motion, remit excess charges made in its bills at any time.

45. (1) When the Board is satisfied that any charge leviable under this Chapter Notice of has been short levied or erroneously refunded, it may issue a notice to the person payment of who is liable to pay such charge or to whom the refund has erroneously been made, charges short requiring him to show cause why he should not pay the amount specified in the erroneously notice:

Provided that, no such notice shall be issued after the expiry of three years,-

- (a) when the charge is short levied, from the date of the payment of the charge,
- (b) where a charge has been erroneously refunded, from the date of the refund.
- (2) The Board may, after considering the representation, if any, made by the person to whom notice has been issued under sub-section (1), determine the amount due from such person and thereupon such person shall pay the amount so determined.
- 46. The rates in respect of goods to be landed shall be payable immediately on Time for the landing of the goods and rates in respect of goods to be removed from the payment of premises of the Board or to be shipped for export or to be transhipped shall be rates on spayable before the goods are removed, shipped or transhipped.

 - (2) The goods shall be retained in the custody of the Board at the risk and expense of the owners of the goods until such lien is discharged as hereinafter mentioned and godown and storage rent shall be payable by the party entitled to such goods for the time during which they may be so retained.
 - (3) Upon the production before any officer appointed by the Board in that behalf of a document purporting to be a receipt for, or release from, the amount of such lien, executed by the person by whom or on whose behalf such notice has been given, the Board may permit such goods to be removed after taking reasonable care with respect to the authenticity of such document.

 - (a) if any rates payable to the Board in respect of such goods have not been paid, or
 - (b) if any rent payable to the Board in respect of any place on or in which such goods have been stored has not been paid, or
 - (c) if any lien of any ship-owner for freight or other charges of which notice has been given has not been discharged and if the person claiming such lien for freight or other charges has made to the Board an application for such sale.
 - (2) Before making such sale, the Board shall give ten days notice of the same by publication thereof in the Official Gazette, and also in at least one of the principal local daily newspapers:

Provided that, in the case of animals and perishable or hazardous goods the Board may give such shorter notice and in such manner as, in the opinion of the Board, the urgency of the case admits of.

(3) If the address of the owner of the goods has been stated in the manifest of the goods or in any of the documents which have come into the possession of the Board or is otherwise known, notice shall also be given to him by letter delivered at such address or sent by post, but the title of a bonafide purchaser of such goods shall not be invalidated by reason of the ommission to send such notice nor shall any such purchaser be bound to inquire whether notice has been sent.

(4) Notwithstanding anything contained in this section, controlled goods may be sold at such time and in such manner as the Government may direct.

Explanation.—In this section and section 50 "controlled goods" means goods the price or disposal of which is regulated under any law for the time being in force.

50. (1) Notwithstanding anything contained in this Act, where any goods placed Disposal of in the custody of the Board upon the landing thereof are not removed by the owner goods not or other person entitled thereto from the premises of the Board within one month from from the date on which such goods were placed in their custody the Board may, permises of if the address of such owner or person is known, cause a notice to be served Board upon him by letter delivered at such address or sent by post, or if the notice cannot within limit. be so served upon him or his address is not known, cause a notice to be published in the Official Gazette, and also in at least one of the principal local dialy newspaper requiring him to remove the goods forthwith and starting that in default of compliance therewith the goods are liable to be sold by public auction or by tenderly agreement or in any other manner:

Provided that, where all the rates and charges payable under this Act in respect of any such goods have been paid, no notice of removal shall be so served or published under this sub-section unless two months have expired from the date on which the goods were placed in the custody of the Board.

- (2) The notice referred to in sub-section (1) may also be served on the agents of the vessel by which such goods were landed.
- (3) If such owner or person does not comply with the requisition in the notice served upon him or published under sub-section (1), the Board may, at any time after the expiration of two months from the date on which such goods were placed in its custody, sell the goods by public auction or, in such cases as the Board considers it necessary so to do, for reasons to be recorded in writing, sell by tender agreement or in any other manner such goods or so much thereof in the opinion of the Board may be necessary after giving notice of the sale in the manner specified in sub-sections (2) and (3) of section 49.
 - (4) Notwithstanding anything contained in sub-section (1) or sub-section (3).—
 - (a) the Board may in the case of animals and perishable or hazardous goods give notice of removal of such goods although, the period of one month or as the case may be, of two months specified in sub-section (1) has not expired or give such shorter notice of sale in such manner as in the opinion of the Board the urgency of the case requires:
 - (b) controlled goods may be sold in accordance with the provisions of subsection (d) of section 49.
 - (5) The Government may, if it deems necessary so to do in the public interest by notification in the Official Gazette, exempt any goods or classes of goods from the operation of this section.
- 51. (1) The proceeds of every sale under section 49 or section 50 shall be applied in the following order :-

(a) in payment of the expenses of the sale;

(b) in payment, according to their respective, priorities of the liens and claims excepted in sub-section (2) of section 47 from the priority of the lien of the Board;

(c) in payment of the rates and expenses of landing, removing, storing or warehousing the same and of all other charges due to the Board in respect thereof including demurrage (other than the penal demurrage) payable in respect of such goods for a period of four months from the date of landing;

Application of sale proceeds.

- (d) in payment of any penalty or fine due to the Central Government under any law for the time being in force relating to customs;
 - (e) in payment of any other sum due to the Board.
- (2) The surplus, if any, shall be paid to the importer, owner or consignee of the goods or to his agent, on an application made by him in this behalf within six months from the date of the sale of the goods.
- (3) Where no application has been made under sub-section (2), the surplus shall be applied by the Board for the purposes of this Act.
- 52. (1) If the master of any vessel in respect of which any rates or penalties are rates and payable under this Act, or under any regulations or orders made in pursuance therecharges by of, refuses or neglects to pay the same or any part thereof on demand, the Board vessel may distrain or arrest such vessel and tackle, apparel and furniture belonging thereto or any part thereof and detain the same until the amount so due to the Board, together with such further amount as may accrue for any period during which the vessel is under distraint or arrest, is paid.
 - (2) In case any part of the said rates or penalties or of the cost of the distress or arrest or the keeping of the same, remains unpaid for period of five days next after any such distress or arrest has been so made, the Board may cause the vessel or other thing so distrained or arrested to be sold and with the proceeds of such sale, shall satisfy such rates or penalties and costs, including the cost of sale remaining unpaid, rendering the surplus (if any), to the master of such vessel on demand.

Grant of clearance after payment of rates, realisation of damages,

- 53. If the Board gives to the officer of the Central Government whose duty is part to grant the port clearance to any vessel at the port, a notice stating—
 - (i) that an amount specified therein is due in respect of rates, fines, penalties or expenses chargeable under this Act or under any regulations or orders made in pursuance thereof, against such vessel, or by the owner or master of such vessel in respect thereof, or against or in respect of any goods on board such vessel; or
 - (ii) that an amount specified therein is due in respect of any damage referred to in section 100 and such amount together with the cost of the proceedings for the recovery thereof before a Magistrate under that section has not been realised, such officer shall not grant such port-clearance until the amount so chargeable or due has been paid or, as the case may be, the damage and cost have been realised.

CHAPTER VII

BORROWING POWERS OF BOARD.

- (4) If at any time before the Board becomes discharged under the provisions of this Act from liability in respect of any security the whole of which is alleged to have been lost, stolen or destoyed, such security is found, any order passed in respect thereof under this section shall be cancelled.

- (b) shall not be taken, without the previous sanction of the Government, if, at any time in any year the amount of such overdrafts, or other loans exceeds such amount not exceeding ten lakhs of rupees, as the Government may fix in this behalf:

Provided further that, all moneys so borrowed by overdrafts or otherwise shall be expended for the purposes of this Act.

72. CHAPTER VIII

REVENUE AND EXPENDITURE

73.  - (f) such sums as may, from time to time, be agreed upon by the Board and the Government or the Central Government or any other authority, as a reasonable contribution payable by the Board towards the expenses in connection with the watch and ward functions of the Police Force or the Central Industrial Security Force or any other Force which the Government or the Central Government or any other authority, as the case may be, may establish and maintain for the protection of the port and the docks, warehouses and other property of the Board:
 - (g) the cost of repairs and maintenance of the property belonging to, or vested in, the Board and all charges upon the same and all working expenses;
 - (h) the cost of the execution and provisions of any new work or appliance specified in section 25 which the Board may determine to charge to revenue;
 - (i) any expenditure incurred under section 26;
 - . (j) any other expenditure which may be incurred by the Board generally for the purposes of this Act:
 - (k) any other charge which may on the application of the Board or otherwise be specially sanctioned by the Government or for which the Board may be legally liable.

- (2) All moneys standing at the credit of the Board which cannot immediately be applied in the manner or for the purposes specified in sub-section (1) shall,—

82. (1) Subject to such conditions as may be specified by the Government, where Witting-offthe Board is of opinion that any amount due or any loss, whether of money or of losses. property, incurred by the Board is irrecoverable, the Board may, with the previous. approval of the Government, sanction the writing-off finally of the said amount or loss:

Provided that, no such approval if the Government, shall be necessary where such irrecoverable amount or loss does not exceed in an individual case, twenty-five thousand rupees or in the aggregate in any year, five lakhs of rupees.

(2) Notwithstanding anything contained in sub-section (1), where the Chief Executive Officer is of opinion that any amount due to or any loss, whether of money or of property, incurred by the Board is irrecoverable, the Chief Executive Officer may sanction the writing-off finally of such amount or loss provided that such amount or loss does not exceed, in an individual case, five thousand rupees or in the aggregate in any one year, one lakh of rupees and in every such case, the Chief Executive Officer shall make a report to the Board giving reasons for such sanction.

83.  - (5) The Government may sanction the estimate or may return it with remarks and may call for such additional information as it may deem necessary.
 - (6) When an estimate is returned under sub-section (5), the Board shall proceed to reconsider the estimate with reference to such remarks and shall furnish such additional information as the Government may call for and shall, it necessary, modify or alter the estimate and resubmit it to the Government.
 - (7) The Government shall sanction the estimate with or without modification.
 - (8) Where such estimate is not sanctioned by the Government before the commencement of the financial year to which it relates, the Government may authorise the Board to incur such expenditure as may be necessary in the opinion of the Government until such time as the approval of the estimate by the Government is communicated to the Board.
- 85. The Board may in the course of any year for which an estimate has been Preparation of supple-sanctioned by the State Government cause one or more supplementary estimates mentary for the residue of such year to be prepared and the provisions of section 84 shall, estimates. so far as may be, apply to such estimate as if it were an original annual estimate.
- 86. Subject to any directions which the Government may give in this behalf riation of any sum of money or part thereof, of which the expenditure has been authorised in amount in an estimate for the time being in force sanctioned, by the Government and which estimates. has not been so spent, may at any time be reappropriated by the Board to meet any excess in any other expenditure authorised in the said estimate.

(1) Subject to the provision of section 86, no sum exceeding such amount to estimate except in the Government may fix in this behalf shall, save in cases of emergency, be expendied emergency. by, or on behalf of, the Board unless such sum is included in some estimate of the Board at the time in force which has been finally sanctioned by the Government.

- (2) If any sum exceeding such limit as may have been fixed in this benalf under sub-section (I) is so expended by the Board on a pressing emergency, the circumstances shall be forthwith reported by the Chief Executive Officer to the Government together with an explanation of the way in which it is proposed by the Board to cover such extra expenditure.
- 88. (1) The Board shall maintain proper accounts and other relevant records Accounts and prepare the annual statement of account including the balance-sheet in such and audits. form as may be approved by the Government.
- (2) The accounts of the Board shall be audited once in every year and if so required by the Government concurrently with the compilation of such accounts by an auditor appointed by the Government in consultation with the Comptroller and Auditor General of India (hereinafter referred to as "the Auditor") and any amount payable to such Auditor by the Board in respect of such audit shall be debitable to the General Fund of the Board.
- (3) The Auditor shall have the same rights, privileges and authority in connection with the audit of the accounts of the Board as the Comptroller and Auditor General of India has in connection with the audit of the Government accounts and in particular, shall have the right to demand production of books of accounts, connected vouchers and other documents of the Board.
- 89. (1) Within fourteen days after the audit and examination of the accounts Publication of the Board have been completed, the Auditor shall forward copies of the audit of audit report to the Government and to the Board.
- (2) The Government shall cause every audit report to be laid for not less than thirty days before the State Legislature as soon as may be after such report is received by the Government.
- 90. The Board shall forthwith take into consideration any defects or irregularities Board to that may be pointed out by the Auditor, in the audit report on the income and remedy expenditure of the Board and shall take such action thereon as the Board may think defects and irregularities fit and shall also send a report of the action so taken to the Government.

- (2) The Government shall cause every annual administration report to be laid for not less than thirty days before the State Legislature as soon as may be, after such report is received by the Government.

- 93; (1) The Board shall annually, or aften, or if directed by the Governme of so to do, submit statement of its income and expenditure in such form and at such statement of size of the control of the c income and time as the Government may direct.
 - (2) A copy of all such statem its shall be open to inspection of the public at the office of the Board during office hours on payment of such fee for each inspection as may, from time to time, be fixed by the Board.

Power of Government to supersede Board.

- 94. (1) If, at any time, the Government is of opinion,—
- (a) that on account of a grave emergency, the Board is unable to perform the duties imposed on it by or under the provisions of this Act or of any other law; or
- (b) that the Board has persistently made default in the performance of the duties imposed upon it by or under the provisions of this Act or of any other law and as a result of such default, the financial position of the Board or the administration of the ports has greatly deteriorated,

the Government may, by notification in the Official Gazette, supersede the Board for such period, not exceeding six months at a time, as may be specified in the notification:

Provided that, before issuing a notification under this sub-section for the reasons mentioned in clause (b), the Government shall give a reasonable opportunity to the Board to show cause why it should not be superseded and shall consider the explanations and objections, if any, of the Board.

- (2) Upon the publication of notification under sub-section (1) superseding the Board,--
 - (a) all the members of the Board shall, as from the date of supersession, vacate their offices as such members of the Board:
 - (b) all the powers and duties which may, by or under the provisions orf this Act, or of any other law, be exercised or performed by or on behalf of the Board shall, until the Board is reconstituted under clause (b) or clause (c) of sub-section (3), be exercised and performed by such person or persons as the Government may direct;
 - (c) all property vested in the Board shall, until the Board is reconstituted under clause (b) or (c) of sub-section (3), vest in the Government.
- (3) On the expiration of the period of supersession specified in the notification issued under sub-section (1), the State Government may,—
 - (a) extend the period of supersession for such further term, not exceeding six months, as it may consider necessary; or
 - (b) reconstitute the Board by fresh appointment and in such case, any person who has vacated his office under clause (a) of sub-section (2) shall not be deemed disqualified for appointment; or
 - (c) reconstitute the Board by appointment only for such period as it may consider necessary and in such a case the persons who vacated their office under clause (a) of sub-section (2) shall not be deemed disqualified for such appointment merely because they were members of the Board when the Board was superseded:

Provided that, the Government may, at any time before the expiration of the period of supersession, whether as originally specified under sub-section (1) or as extended under this sub-section, take action under clause (b) or (c) of this sub-* . . section..

- (4) The Government shall cause a notification issued under sub-section (1) and a full report of any action taken under this section and the circumstance leadings to such action to be laid before the State Legislature at the earliest possible oppostunity.
- 95. (1) Without prejudice to the foregoing provisions of this Chapter, the Board Power of shall, in the discharge of its functions under this Act, be bound by such direction Government on question of policy, as the Government may give in writing to it from time to directions to

Other 101. Any person who contravenes any of the provisions of this Act, or of any offences, rule, regulation or order made thereunder for the contravention of which no penalty is expressly provided thereunder, shall, on conviction, be punishable with fine which may extend to one thousand rupees.

Cognizance 102. No court inferior to that of a Metropolitan Magistrate or Judicial of offences. Magistrate of the first class shall try any offence punishable under this Act or any rule or regulation made thereunder.

Offence by 103. (1) If the person committing an offence under this Act is a company, every companies, person who, at the time the offence was committed was in charge of, and was responsible to, the company for the conduct of business of the company, as well as the company, shall be deemed to be guilty of the offence and shall be liable to be proceeded against and punished accordingly:

Provided that, nothing contained in this sub-section shall render any such person liable to such punishment provided in this Act if he proves that the offence was committed without his knowlede or that he exercised all due deligence to prevent the commission of such offence.

(2) Notwithstanding anything contained in sub-section (1), where an offence under this Act has been committed by a company and it is proved that the offence has been committed with the consent or connivance of or that the commission of the offence is attributable to any negligence on the part of any director, manager, secretary or other officer of the company, such director, manager, secretary or other officer of the company shall also be deemed to be guilty of that offence and shall be liable to be proceeded against and punished accordingly.

Explanation.—For the purposes of this section,—

- (a) "Company" means a body corporate and includes a firm or other association of individuals; and
 - (b) "director" in relation to a firm, means a partner in the firm.

CHAPTER XI

MISCELLANEOUS

104. (1) The Government may, from time to time, constitute for such ports as Local it may determine Local Advisory Committees, consisting of such number of persons Advisory as it may think fit in each case and on such terms and conditions as may be prescribed by rules.

- (2) The Board may, if it thinks fit, consult the Local Advisory Committee concerned on any business coming before it and shall do so in respect of such busins the Government may, by general or special order in this behalf, specify or when required by the regulations so to do.
- (3) The Port Officer, appointed under the Indian Prots Act, shall be the exofficio Chairman of a Local Advisory Committee.
- (4) The Local Advisory Committee shall meet at such intervals as may be pres ribed by rules and for the transaction of urgent business on such other occasio as the Chairman of the Board may require.
- (5) The number of members necessary to constitute a quorum at a meeting of any Local Advisory Committee shall be, as the Government when constituting the Committee may specify.
- 105. No suit or other proceeding shall be commenced against the Board or any Limitation of member or employee thereof for anything done, or purporting to have been done proceedings in pursuance of this Act until the expiration of one month after notice in writing of thing has been given to the Board or to such member or employee stating the cause of done under action or after six months after the accrual of the cause of action.
- 106. No suit or other legal proceeding shall lie against the Board or any member Protection or employee thereof in respect of anything which is in good faith done or intended of act done to be done under this Act or any rule or regulation made thereunder, or for any in good damage sustained by any vessel in consequence of any defect in any of the mooring, hawsers or other things belonging to, or under the control of, the Board.
- 107. (1) The Government may, by notification in the Official Gazette, make Power of State rules for carrying out the purposes of this Act.

Power of State Government to make

- (2) In particular and without prejudice to the generality of the foregoing power, to make such rule may be made for all or any of the following matters, namely:
- (a) fees and allowances payable to the members of the Board or any of its committees for attending meetings of the Board or its committee or for attending any work of the Board, under section 12;
 - (b) the terms and conditions of service of the Chief Executive Officer under sub-section (2) of section 17;
 - (c) the form and manner of executing contracts under section 24;
 - (d) the terms and conditions on which the Board with the previous sanction of the Government, may raise loans under sub-section (1) of section 54;
 - (e) the terms and conditions of appointment of persons as member of aLocal Advisory Committee under sub-section (1) of section 104; and

- (f) any other matter which is to be or may be prescribed by rules.
- (3) All rules made under this Act shall be subject to the condition of previous publication:

Provided that, if the Government is satisfied that circumstances exist which render it necessary to take immediate action, it may dispense with previous publication of any rule to be made under this section.

(4) Every rule made under this Act shall be laid, as soon as may be, after it is made, before each House of the State Legislature, while it is in session for a total period of thirty days, which may be comprised in one session or in two successive sessions, and if, before expiry of the session in which it is so laid or the session immediately following, both the Houses agree in making any modification in the rule or both the Houses agree that the rule should not be made, and notify their decision to that effect in the Official Gazette, the rule shall, from the date of publication of such decision in the Official Gazette, have effect only in such modified form or be of no effect, as the case may be, so however that, any such modification or annulment shall be without prejudice to the validity of anything previously done or omitted to be done under that rule, .

Power regulations.

- 108. The Board may, with the previous approval of the Government, make to make regulations consistent with this Act, and the rules made thereunder, to carry out the purposes of this Act, and without projudice to the generality of this power such regulations may provide for all or any of the following matters, namely:
 - (1) the time and place of the meetings of the Board or its committees, the procedure to be followed for the transaction of business at such meetings and the number of members necessary to constitute a quorum at such meetings:
 - (2) the appointment, promotion, suspension, removal and dismissal of its officers and employees;
 - (3) leave, leave allowances, pensions, gratuities, compassionate allowances and travelling allowances of the officers and employees and the establishment and maintenance of a provident fund of any other fund for their welfare:
 - (4) the time within which and manner in which appeals may be p efe red under sub-section (2) of section 19 and the procedure for deciding such appeals:
 - (5) the terms and conditions of service of persons who become employees of the Board under clause (f) of section 20;
 - (6) any other matter which is incidental to, or necessary for, the purpose of regulating the appointment and conditions of service of its employees;
 - (7) the form of receipt to be given under sub-section (2) of section 32;
 - (8) the period within which notice may be given under sub-section (2) of section 33;
 - (9) the guidence of persons employed by the Board under this Act;
 - (10) the safe, efficient and convenient use, management and control of the docks, wharves, quays, jetties, buildings and other works constructed or acquired by, or vested in, the Board, or of any land or foreshore acquired by, or vested in, the Board under this Act;
 - (11) the reception, porterage, storage and removal of goods brought within the premises of the Board, for the exclusive conduct of these operations by the Board or persons employed by the Board, and for declaring the procedure to be followed for taking charge of goods which may have been damaged before landing, or may be alleged to have been so damaged;

- (12) keeping clean the port, river or basins or the bank of the river and the works of the Board, and for preventing filth or rubbish being thrown therein or thereon;
 - (13) the mode of payment of rates leviable by the Board under this Act;
- (14) regulating, declaring and defining the docks, wharves, quays, jetties, stages and piers vested in the Board on which goods shall be landed from vessels and shipped on board vessels;
- (15) regulating the manner in which and the conditions under which the loading and unloading of all vessels within the port or port approaches shall be carried out:
- (16) regulating the lightcrage of cargo between ships or between ships and shore or between shore and ships;
- (17) the exclusion from the premises of the Board of disorderly or other undesirable persons and of trespassers;
 - (18) ensuring the safety of the port;
 - (19) generally for the efficient and proper administration of the ports;
- (20) the person, if any, authorised to sign and the mode of affixing the corporate seal and of attestation of documents relating to Board Securities issued or to be issued by the Board;
- (21) the manner in which payment of interest in respect of such Board Securitie to be made, recorded and acknowledged;
- (22) the circumstances and the manner in which Board Securities may be renewed;
- (23) the circumstances in which such securities must be renewed before further payment of interest thereon can be claimed;
- (24) the form in which such securities delivered for renewal, conversion, consolidation or sub-division are to be receipted
- (25) the proof which is to be produced by a person applying for duplicate securities;
- (26) the form and manner of publication of the notification mentioned in sub-section (2) of section 61 and the manner of publication of the list mentioned in sub-section (3) of that section.
- (27) the nature and amount of indemnity to be given by a person applying for the payment of interest on the Board Accurities alleged to have been wholly or partly lost, stolen or destroyed, or for the issue of duplicate Board Securities;
- (28) the conditions subject to which Board Securities may be converted, consolidated or sub-divided;
 - (29) the amounts for which stock certificate may be issued;
- (30) generally all matters connected with grant of duplicate, renewal, conversion, consolidation and sub-division of securities;
- (31) the fees to be paid in respect of the issue of duplicate securities and of the renewal, conversion, consolidation and sub-division of Board Securities;
 - (32) the fees to be levied in respect of the issue of stock certificate;
 - (33) any other matter, which is to be, or may be, prescribed by regulations.

Provisions respect to regulations.

- 109. (1) No regulation made by the Board under this Act shall have effect until with the same has been published by the Board in the Official Gazette.
 - (2) Any regulation made under this Act may provide that a breach thereof shall, on conviction, be punishable with fine which may extend to two hundred rupees and where the breach is a continuing one, with further fine which may extend to fifty rupees for every day during which such breach continues.
