MAHARASHTRA ACT No. VII OF 20051.

I THE MAHARASHURA ZILLA PARISHADS AND PANCHAVAT SAMUUS TEMPORARY POSTPONEMENT OF ELECTIONS (OF THE PRESIDENT, VICE PRESIDENT AND CHAIRMEN OF SUBJECTS COMMITTEES OF CERTAIN ZILLA PARISHADS AND CHAIRMEN AND DEPLITY CHAIRMEN OF CERTAIN PANCHAYAT SAMITIS DIJE TO ENSUING GENERAL ELECTIONS TO THE STATE LEGISLATIVE ASSEMBLY AND CERTAIN OTHER ELECTIONS) ACT. 2004.1

(This Act received the assent of the Governor on the 4th January 2005: assent was first published in the Maharashtra Government Gazette, Extraordinary, Part IV, on the 4th January 2005.)

An Act to provide for temporary postponement of elections of the President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chairmen of certain Panchavat Samitis on account of ensuing general elections to the State Legislative Assembly and certain other elections.

WHEREAS both Houses of the State Legislature were not in session:

Mah. XXIV of 2004.

AND WHEREAS the Governor of Maharashtra has Ord. promulgated the Maharashtra Zilla Parishads and Panchayat Samitis Temporary Postponement of Elections (of the President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chairmen of certain Panchayat Samitis due to ensuing general elections to the State Legislative Assembly) Ordinance, 2004 (hereinafter referred to as "the said Ordinance") on the 21st August 2004, to provide for temporary postponement of the elections of the President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chairmen of certain Panchayat Samitis for a period of three months on account of general elections to the State Legislative Assembly;

AND WHEREAS the extended term of offices of the President. Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chairmen of certain Panchayat Samitis was due to expire on the 18th November 2004;

Maharashtra Zilla Parishads and Panchayat Samitis [2005 : Mah. VII Temporary Postponement of Elections (of the President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chairmen of Certain Panchayat Samitis due to ensuing general elections to the State Legislative Assembly and certain other elections) Act, 2004.

AND WHEREAS with a view to further extend the term of office of the President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chairmen of certain Panchayat Samitis for further period of three months due to general elections of certain Panchayat Samitis and bye-elections for filling up some vacancies of the councillors of certain Zilla Parishads and the members of certain Panchavat Samitis, as well as elections to eleven seats to Maharashtra Legislative Council including six seats from local authorities constituencies, the Governor of Maharashtra has promulgated the Maharashtra Mah. Zilla Parishads and Panchayat Samitis Temporary Postponement of Elections (of the President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chairmen of certain Panchayat Samitis due to ensuing general elections to the State Legislative Assembly) (Amendment) Ordinance, 2004, on the 11th November 2004;

AND WHEREAS it is expedient to replace the said Mah. Ordinance, as amended by the Maharashtra Zilla Parishads and Panchayat Samitis Temporary Postponement of Elections (of the President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen Deputy Chairmen of certain Panchayat Samitis due to ensuing general elections to the State Legislative Assembly) (Amendment) Ordinance, 2004; by an Act of the State Legislature; it is hereby enacted in the Fifty-fifth Year of the Republic of India as follows:--

XXXII 2004.

Short title. duration.

- 1. (1) This Act may be called the Maharashtra Zilla commence Parishads and Panchayat Samitis Temporary Postponement of Elections (of the President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chairmen of certain Panchayat Samitis due to ensuing general elections to the State Legislative Assembly and certain other elections) Act, 2004.
 - (2) It shall be deemed to have come into force on the 21st August 2004.
 - (3) It shall remain in force for the period of six months from the date of commencement of this Act or such earlier date as may be notified by the State Government by issuing a notification in the Official Gazette; and shall then expire. Section 7 of the Bombay General Clauses Act, 1904, shall apply upon the expiry of this Act, as if it had been repealed by a Maharashtra Act.

2. In this Act, unless the context otherwise requires,—

Definitions

- (a) "Panchayat Samiti" means a Panchayat Samiti constituted under the Zilla Parishads Act:
- (b) "Zilla Parishad" means a Zilla Parishad constituted under the Zilla Parishads Act:
- (c) "Zilla Parishads Act" means the Maharashtra Zilla Mah. Vof Parishads and Panchavat Samitis Act, 1961;
- (d) words and expressions used in this Act and not defined herein shall, in relation to any Zilla Parishad or Panchayat Samitis, have the meaning assigned to them in the Zilla Parishads Act.
- 3. (1) Notwithstanding anything contained in the Zilla Parishads Act or the rules made thereunder or in any judgement, decree or order of any Court,-
 - (a) no election to the offices of the President. Vice-President and the Chairmen of the Subjects Committees of a Zilla Parishads, and the Chairmen and Deputy Chairmen of a Panchayat Samitis shall be held for a period of six months from the date of coming into force of this Act, or till such earlier date as may be notified by the State Government by issuing a notification under subsection (3) of section 1 in the Official Gazette (hereinafter in this Act referred to as "the said period");
 - (b) the term of offices of the President, Vice-President and Chairmen of the Subjects Committees of a Zilla Parishad and Chairmen and Deputy Chairmen of a Panchavat Samiti elected after the said period shall be co-terminous with the term of the elected Councillors or members, as the case may be.
- (2) Notwithstanding anything contained in sub-section (1), after the term of offices of the President, Vice-President, and Chairmen of the Subjects Committees of the Zilla Parishads and the Chairmen and Deputy Chairmen of the Panchayat Samitis as extended by this Act expires, they shall continue to hold office until the new President, Vice-President and Chairmen of the Subjects Committees and Chairmen and Deputy Chairmen have been elected under the Zilla Parishads Act.

Power of Vice-Presidents. Chairmen. Deputy Chairmen of office

4. All the Presidents, Vice-Presidents and Chairmen of President, the Subjects Committees of the Zilla Parishads and Chairmen and Deputy Chairmen of the Panchayat Samitis, whose term of offices are deemed to have been extended or are extended, as the case may be, under section 3 shall, throughout the extended period, be deemed to have been and be competent to exercise all the powers, perform all the duties and discharge all the functions as such President, of Subjects Vice-President and the Chairmen of the Subjects Committees Committees of the Zilla Parishads and Chairmen and Deputy Chairmen whose term of the Panchayat Samitis; and no act done by any of them during said period shall be invalid or shall be called in extended question in any Court, merely on the ground that during and such extended period, the President, Vice-President and the validation Chairmen of the Subjects Committees, and the Chairman and of certain Deputy Chairman of the Panchayat Samitis, could not exercise acts. all or any of the powers or perform all or any of the duties or discharge all or any of the functions of the President. Vice-President and Chairmen of the Subjects Committees and Chairmen and Deputy Chairmen of the Panchayat Samitis.

Arrangeelections of Presidents. of Subjects

5. Notwithstanding anything contained in this Act, ments to arrangements shall be made by the Collectors and other officers concerned to hold the elections of the Presidents, Vice-Presidents, Chairmen of the Subjects Committees of the Vice- Zilla Parishads and Chairmen and Deputy Chairmen of the Presidents, Panchayat Samitis, in accordance with the provisions of the Chairmen, Deputy Zilla Parishads Act and the rules made thereunder, before, Chairmen or as soon as possible, after the expiration of the extended and term of office of the Presidents, Vice-Presidents and Chairmen Chairmen of the Subjects Committees of the Zilla Parishads Committees and Chairmen and Deputy Chairmen of the Panchayat Samitis.

If any difficulty arises in giving effect to the provisions difficulty. of this Act or by reason of anything contained therein, or in giving effect to the Zilla Parishads Act in respect of any matter contained in this Act, the State Government may as occasion arises, by order, do anything which appears to it to be necessary for the purpose of removing the difficulty.

7. (1) The Maharashtra Zilla Parishads and Panchayat Mah. Samitis Temporary Postponement of Elections (of the XXIV of President, Vice-President and Chairmen of Subjects Committees of certain Zilla Parishads and Chairmen and Deputy Chainmen of certain Panchayat Samitis due to ensuing general election to the State Legislative Assembly and certain other elections) Ordinance, 2004, is hereby repealed.

(2) Notwithstanding such repeal anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the provisions of this Act.
