The following Act of the Andhra Pradesh Legislative Assembly received the assent of the Governor on the 11th May, 1990 and the said assent is hereby first published on the 14th May, 1990 in the Andhra Pradesh Gazette for general information:—

**ACT No. 9 OF 1990.**

An Act further to amend the Telugu University Act, 1985.

Be it enacted by the Legislative Assembly of the State of Andhra Pradesh in the Forty-first Year of the Republic of India, as follows:—

1. (1) This Act may be called the Telugu University (Amendment) Act, 1990.

(2) It shall be deemed to have come into force on the 5th February, 1990.

2. In the Telugu University Act, 1985, in section 9, in sub-section (1), for the words "Chief Minister", the word "Governor" shall be substituted.

3. The Telugu University (Amendment) Ordinance, 1990 is hereby repealed.

AN ACT TO AMEND THE TELUGU  
UNIVERSITY ACT, 1985

Enacted by the Legislative  
Assembly of the State of Andhra Pradesh on  
the Forty-Eighth Year of the Republic of  
India as follows:-

(1) This act may be called the  
Telugu Universities (Amendment) Act, 1994.

(2) It shall be deemed to have come  
into force on the 29th April, 1994.

Amendment of section 8, Act 27 of 1985. 2. In the Telugu University Act, 1985 (hereinafter referred to as the Principal Act), in section 8, after clause (1), the following shall be inserted, namely:-

"(1A) the Pro-Chancellor;".

Insertion of new section 9A. 3. In the principal Act, after section 9, the following new section shall be inserted, namely:-

"Pro-Chancellor | 9A. (1) The Pro-Chancellor of the University shall be nominated by the Chancellor and shall hold office for a period of three years.

(2) In the absence of the Chancellor or during the Chancellor's inability to act, the Pro-Chancellor shall perform all the functions of the Chancellor."

Repeal of Ordinance 2 of 1994. 4. The Telugu University (Amendment) Ordinance, 1994 is hereby repealed.

AN ACT FURTHER TO AMEND THE TELUGU  
UNIVERSITY ACT, 1985.

Enacted by the Legislative  
Assembly of the State of Andhra Pradesh in  
the Forty-seventh Year of the Republic of  
India as follows:-

1. This Act may be called the Telugu University (Amendment) Act, 1996.

Amendment of section 1. 2. In the Telugu University Act, 1985 (hereinafter referred to as the principal Act) in section 1, in sub-section (1), for the expression "Telugu University Act 1985", the expression "Potti Sreeramulu Telugu University Act 1985" shall be substituted.

Amendment of section 2. 3. In section 2 of the principal Act, in clause (i), for the words "Telugu University", the words "Potti Sreeramulu Telugu University" shall be substituted.

Amendment of section 3. 4. In section 3 of the principal Act, in sub-section (1), for the words "Telugu University", the words "Potti Sreeramulu Telugu University" shall be substituted.
